WHEREAS, in accordance with the California Environmental Quality Act (CEQA), an Initial Study of the possible environmental consequences of the updated Housing Element has been prepared by Coastplans; and

WHEREAS, it has been determined in the Initial Study that the project will not have a significant effect on the environment and a Negative Declaration can be adopted; and

a Notice of Intent to Adopt a Negative Declaration was WHEREAS, circulated and published for public review and comment in accordance with the requirements of CEQA; and

WHEREAS, no evidence was submitted in response to the Notice of Intent to Adopt a Negative Declaration that indicates the project may actually produce a significant environmental impact; and

WHEREAS, the Planning Commission has reviewed and considered the Initial Study and Negative Declaration at its regular meeting on February 23, 2011, and prior to taking action on the application, the Commission received written and oral reports by the Staff, and received public testimony.

WHEREAS, the City Council approved a work program to update the 2003 Housing Element on January 20, 2009; and

WHEREAS, staff, under the guidance of the City Council-appointed Housing Element Update Advisory Committee, has prepared a draft update to the Housing Element in accordance with the requirements of state Housing Element law; and

WHEREAS, the draft update to the Housing Element has been reviewed by the State Department of Housing and Community Development, who has determined that the draft Housing Element would be found in compliance with the requirements of state Housing Element law if adopted as presented; and

WHEREAS, the Planning Commission considered the proposed update to the Housing Element at its regular meeting on February 23, 2011, and prior to taking action on the proposed update, received written and oral reports by the staff, and received public testimony; and

WHEREAS, the potential environmental impacts of the updated Housing Element were evaluated in an Initial Study that was prepared pursuant to the requirements of the California Environmental Quality Act (CEQA), and

WHEREAS, it was determined that the updated Housing Element would not have a significant impact on the environment and the Planning Commission has recommended to the City Council that a Negative Declaration be adopted.
