## RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CALISTOGA, COUNTY OF NAPA, STATE OF CALIFORNIA, ESTABLISHING A COMMUNITY POOL ADVISORY COMMITTEE AND CONFIRMING THE MAYOR'S APPOINTMENTS

WHEREAS, The City Council has long supported the establishment of a Community Pool to serve the residents of Calistoga; and

WHEREAS, the City Council has previously approved a concept plan for the development of a community pool and a preferred method for the funding of the pool's construction; and

WHEREAS, members of the Calistoga Community Center Pool Project (CCCPP) have requested that the previous actions by the City Council be revisited; and

WHEREAS, the City Council agrees to revisit these previous actions and wishes to receive an evaluation and recommendations on the issues surrounding the development and operation of a Community Pool.

**NOW, THEREFORE BE IT RESOLVED,** that the Calistoga City Council hereby creates a Community Pool Advisory Committee to provide thoughtful and objective recommendations to the City Council. The Committee's charge shall be:

- To review the recommendations from the previous advisory committee, and the actions taken by the City Council regarding the Community Pool;
- Develop recommendations to the City Council regarding the previous recommendations and actions;
- Recommend a scope for the elements of a Community Pool (size of pool, elements of the swim center, ancillary elements, etc.);
- Recommend potential phasing for the pool development and ancillary elements;
- Recommend a funding method(s) for the construction and on-going operations, maintenance, and replacement for the community pool; and
- Recommend a series of next steps to implement the Committee's recommendations.

**BE IT FURTHER RESOLVED,** that the City Council hereby confirms the Mayor's appointments to the Community Pool Advisory Committee:

Two members from the City Council: Mayor Alexander, and Councilmember Slusser.

Two members from the CCCPP: Suzan Shaw and Kerry Eddy.

Two staff members as assigned by the City Manager.
