WHEREAS, the Planning Commission reconsidered proposed revisions to the City's Affordable Housing Regulations and prior to taking action on the application, the Planning Commission received written and oral reports by the staff, and received public testimony;

WHEREAS, An Initial Study/Mitigation Negative Declaration (IS/MND) was completed in accordance with applicable CEQA Guidelines, and on February 1, 2008 the IS/MND was circulated for public and agency review and comment. Copies of the IS/MND were made available to the public at the Department of Planning and Building on February 1, 2008, and the IS/MND was distributed to interested parties and agencies. On February 1, 2008, a notice of the Planning Commission public hearing of March 12, 2008 to review the IS/MND was published in the local newspaper;

WHEREAS, the Planning Commission finds that amending Chapter 17.08 of the Zoning Ordinance to provide an alternative means for residential projects to satisfy the affordable housing requirements is, in part, implementation of General Plan Objective H-3.1, Policy P-3;

WHEREAS, the Planning Commission has recommended the proposed amendment as provided in Exhibit A to provide an alternative means for residential projects to satisfy the affordable housing requirements; and

NOW, THEREFORE, BE IT RESOLVED by the City of Calistoga Planning Commission that, based on the above findings, the proposed amendment pertaining to affordable housing regulations is forwarded to the City Council with a recommendation of adoption.
