**During 1<sup>st</sup> Term:**

- Identified \$81,000 Toni Edgers' bequest re-allocated to Calistoga Library capital improvement fund to "enhance" the facility and entered as a line-item in NCCL accounting;
- Located 1924 Calistoga Bible from the Klu Klux Klan in Napa Main branch;
- Requested Calistoga Library building retroactively be included in Napa County Green House Gases/Carbon Reduction Plan baseline data;
- Requested that building renovations comply with building's Historic Resource status and employ green building principals (have Napa County Public Works apply for CREG Bonds (Clean/California Renewable Energy Bonds) in phase 2, eg. solar generation, insulation lighting, etc.).

**Goals for 2<sup>nd</sup> Term:**

- Assure \$81,000 bequest used appropriately to "enhance" the facility (vs. ADA compliances which is legal obligation of Napa County);
- Return 1924 Calistoga bible to Calistoga Branch Building;
- Continue requests for a Calistoga Library building feasibility study as a component of the Napa County GHG/Carbon Reduction Plan baseline data;
- Continue efforts to make capital improvements to Calistoga Library that comply with historic preservation regulations and green construction energy efficiencies.
