## C) ORAL COMMUNICATION ON CONSENT ITEMS OR NON-AGENDA ITEMS

**Dennis McNay**, **2653 Foothill Blvd.**, spoke regarding the Page Construction payment that was made recently in the amount of \$267,000 and requested a copy of the Settlement Agreement.

**Kurt Larrecou,** stated his concerns regarding the Consultant Services Agreement the City has with Joel Galbraith and Associates in connection to the processing of the Silver Rose resort development project.

Administrative Services Director Leon, presented a PowerPoint presentation discussing the budget/cash flow situation overview for FY 11/12 year end projections and the budget summary review for FY 12/13 including the General Fund and Enterprise Funds.

City Manager Spitler discussed the City Council/Support Services budget noting that the election budget went up for FY 12/13 due to the November 6, 2012 General Municipal Election.

#### Public Speaking to the items:

**Lilia Tisen**, speaking on behalf of the Chamber of Commerce, discussed the destination marketing service contract budget.

Carlene Moore, speaking on behalf of the Napa County Fairgrounds, stated her concerns regarding possibly cutting the Chamber of Commerce's funding and feels that it is important to maintain the funding they currently receive.

**Georgi Carlin-Costello, 1623 Lake St.,** supported Carlene Moore's statements and encouraged the Council not cut the Chamber's budget.

Margaret Law, spoke in support of the Chamber of Commerce and would like Council to reconsider cutting their budget.

Staff and Council discussion ensued.

**Recreation Services Manager Lemen** discussed the Recreation Division budget.

Administrative Services Director Leon continued discussion on the Administrative Services Department budget.

Fire Chief Campbell discussed the Fire Department budget.
