**A RESOLUTION HONORING NICHOLAS KITE FOR HIS SERVICE ON THE PLANNING

1 **WHEREAS**, Nicholas Kite was appointed to the Planning Commission by the City
2 Council on December 19, 2006 and served through November 20, 2012, during which time he
3 attended over 144 meetings, representing over 300 hours of preparation and deliberation; and

5 **WHEREAS**, during his tenure as Planning Commissioner, Nicholas Kite has acted
6 responsibly in his role preserving, protecting and enhancing Calistoga's unique small-town
7 community character for residents and visitors alike during a period of economic change and
8 diversity; and

10 **WHEREAS**, during this period, Nicholas Kite played a significant role in numerous
11 planning and zoning decisions, ranging from long-range planning matters to major development
12 projects. Nicholas Kite provided recommended actions on projects such as the Urban Design
13 Plan, an Update to the Housing Element, the Silver Rose Redevelopment Project, Indian
14 Springs Expansion Project and the Enchanted Resorts Project; and

16 **WHEREAS**, when developing his recommendations, Nicholas Kite conscientiously
17 balanced the broader needs of the community with his expertise and interest in economic vitality
18 and maintaining Calistoga's community character; and


20 **WHEREAS**, because of his knowledge, experience and his dedication to Calistoga,


23 **WHEREAS**, the City of Calistoga Planning Commission expresses its sincere
