The opening was also placed as a display ad in the Calistoga Tribune on two occasions. The City did not receive any applications as a result of these solicitations. However, Napa County did receive an application on October 11, 2012 from Christina Aranguren which was forwarded to the city of Calistoga. The former Mayor did not give direction to staff to process this application.
