

Life Experiences

I immigrated to this country almost 23 years ago. After living in San Francisco for about 10 years I chose to move to Calistoga because it was a perfect place to raise my two daughters. I fell in love with this beautiful city and the Napa Valley.

Since I moved here, I always tried to get involve in the school system and the community. I have participated in different events, committees, fundraisers, etc., the benefited the seniors, the children and the community in general. Of special interest for me have been events that promote the positive interaction of the Anglo and Latino communities.

I established my senior in-home services business in Calistoga, and I operated a retail business in Lincoln Ave and the Farmers Market. At the moment, I am in the process of obtaining a license for a Residential Care Facility for the Elderly, which will serve the senior population in our town. Working with the seniors had given me the opportunity to understand the needs and concerns of this important segment of our community.

Since 2007, I have been part of the committee that organizes the Celebration of the Mexican Independence Day in the month of September. In 2009 and 2010 I worked with the Calistoga Family Center organizing the Calistoga Tamale Festival. This festival provided a venue for families to enjoy a safe and fun day promoting the positive interaction of all the important

members of our population: the seniors, the children, the Latino, the Anglo and other members of our community.

I firmly believe that by working together we can improve the living conditions of all the inhabitants of the community.

I wish to serve because I feel part of this community. As a Latino woman I know that it is important for us to participate in Calistoga's civic life, bringing all our knowledge and experience. 

- 2) Years of being on the "doing" side of volunteering instead of as a decision-maker/leader. I've spent a lot of time implementing the ideas of committees and have learned about effective leadership from the downside up: Effective leaders not only have clear ideas; they recognize who individuals are and their probable if not recorded capabilities; they communicate well, offering encouragement and sorting out problems early; they keep track of the whole organization by noticing what is getting done and who is doing it, always optimizing the productivity of talent before it walks away.
- 3) This past year I have been involved with two referendum movements, two more than have taken place in this valley in many, many years. I've learned a lot about organization, communication, cooperation, and collaboration, especially of a very diverse group of people, specifically Calistogans. Some useful lessons I've learned in life and especially during the referendum process: Be nice if you want people to cooperate. Choose well; know what kinds of personalities you're dealing with and who can accomplish what. People have full lives; give them manageable jobs with clear descriptions and timelines and stay in touch.
- 4) My tendency is to live and let live, accept people for their differences, not requiring anyone to look act, or think like me. However, sometimes it may be best to interfere with a trajectory. Seeing Zahid declining and dis-integrating from society over several months, thinking about asking my husband if we could invite him to our home to bathe or wash his clothes or share a meal with us, and then learning he had died. I hadn't ever asked my husband, had always forgotten about Zahid by the end of the day, and now will never know if a simple act of kindness and care would have made a difference. The lesson for me is: Don't wait, take action, pick up the phone when my conscience speaks to me.






