# **BACKGROUND AND DISCUSSION**

There are approximately 11,000 veterans of the United States Armed Forces residing in Napa County. In 2012, the Napa County Veterans Advocacy Coalition (NCVAC) was created to identify shortfalls in services provided to veterans and their families residing in the County and to identify solutions to those shortfalls. Specifically, NCVAC seeks to address shortfalls in the areas of housing, transportation and economic hardships.

Membership of NCVAC consists of organizations, agencies, associations and individuals with an active interest in and commitment to support Napa County service members, veterans and their families. NCVAC is comprised of public agencies and nonprofits that have statute or mission-related responsibility to support veterans and their families. The founding members include representatives from: Napa County Red Cross, Napa County Health and Human Services, the Napa County Veterans Service Officer, the City of Napa Housing Authority, the Yountville Veterans Home, the Pathway Home, Napa Valley College, the American Legion, the Vietnam Veterans of America and Operation Iraqi Freedom and Operation Enduring Freedom veterans.

Prospective members of NCVAC are required to submit an application for review by NCVAC members and requires a majority vote for acceptance.
