RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CALISTOGA, COUNTY OF NAPA, STATE OF CALIFORNIA, APPROVING AMENDMENT NO. 5 TO THE PROFESSIONAL SERVICES AGREEMENT WITH LARRY WALKER AND ASSOCIATES FOR ONGOING PERMIT ASSISTANCE SERVICES RELATED TO THE CITY'S WWTP NPDES PERMIT AND THE STATE'S GENERAL WATER REUSE PERMIT

WHEREAS, the City of Calistoga Wastewater Treatment Plant Operates under a National Pollutant Discharge Elimination System (NPDES) Permit that includes certain monitoring and reporting requirements;

WHEREAS, the City of Calistoga operates its Recycled Water Program under the State's General Water Reuse Permit which requires the City to monitor and report all recycled water activities within its jurisdiction; and

WHEREAS, the City requires professional services to assist in the monitoring and reporting requirements of both of these permits; and

WHEREAS, the City of Calistoga entered into an agreement on August 16, 2005, Amendment No. 1 on March 4, 2008, Amendment No. 2 on July 21, 2009, Amendment No. 3 on July 19, 2011, and Amendment No. 4 on August 22, 2012 with Larry Walker Associates for Ongoing Permit Assistance associated with the NPDES and Recycled Water User Permits; and

WHEREAS, Larry Walker Associates and the City of Calistoga wish to amend the contract to include additional ongoing permit services for FY 2013-14; and

WHEREAS, Larry Walker Associates has submitted a proposal for these additional services dated May 15, 2013, in the amount of \$59,810; and

WHEREAS, staff has reviewed said proposal, found that the professional services proposed are reasonable and necessary, and recommends that Amendment No. 5 to the agreement with Larry Walker and Associates be approved.

NOW, THEREFORE BE IT RESOLVED that the City Council of the City of Calistoga hereby approves Amendment No. 5 to the Professional Services Agreement with Larry Walker and Associates in the amount of \$59,810 for a total contract amount of \$196,868 for ongoing permit assistance related to the City of Calistoga Wastewater Treatment Plant NPDES Permit and the State's General Water Reuse Permit; and

BE IT FURTHER RESOLVED that the City Council of the City of Calistoga hereby authorizes the City Manager to execute the required documents subject to review and approval by the City Attorney.
