ISSUE: Consideration of rescinding Resolution No. 2013-007 confirming the Mayor's appointments to local and regional bodies and adopt a new Resolution confirming the Mayor's appointments to local and regional bodies.

RECOMMENDATION: Adopt a Resolution rescinding Resolution 2013-007 and adopting a new Resolution.

<u>DISCUSSION</u>: The City is represented on a number of local and regional boards and typically the Mayor appoints a Councilmember and an alternate to sit on those bodies annually. The Council has on an annual basis revisited appointments to "share the burden" and provide opportunities for Councilmembers to serve on these bodies. Appointments to the various boards were made at the January 15, 2013 City Council Meeting. At this time, the Council only consisted of four Councilmembers, leaving one seat vacant.

At the February 5, 2013 City Council meeting, Ms. Irais Lopez-Ortega was appointed to the City Council, filling the vacant Council seat. Councilmember Lopez-Ortega does not currently sit on any local and regional bodies and it is the Mayor's desire to recommend that she be appointed to serve as a Representative.

The following table outlines the various local and regional bodies that Councilmembers currently sit on as Calistoga's representatives. The Mayor is to propose appointments and the Council is to ratify the appointments after discussion.
