SPECIAL MEETING CALISTOGA CITY COUNCIL GOAL SETTING UPDATE STUDY SESSION MONDAY, MARCH 17 2014- 9:00 A.M. CALISTOGA COMMUNITY CENTER

A. CALL TO ORDER

Mayor Canning called the Special Session to order at 9:09 a.m.
