ISSUE: Consideration of a Resolution approving the 2015 Parade/Event list and authorizing the Public Works Department to apply for encroachment permits from Caltrans.

RECOMMENDATION: Adopt Resolution.

BACKGROUND/DISCUSSION: Every year a variety of local organizations apply to the City of Calistoga to hold parades/processions/events along Lincoln Avenue. Lincoln Avenue is State right-of-way (Hwy. 29) and encroachment permits are therefore required from the California Department of Transportation (Caltrans) for special events thereon. The City's Public Works Department typically has applied to the State for encroachment permits on behalf of the applicants. Attached is a list of the applicants planning parades/processions/events in 2015.
