CONSISTENCY WITH CITY COUNCIL GOALS AND OBJECTIVES: Without the waiving of fees the ability to provide such an event would be significantly diminished, which is inconsistent with the City Council Objective 1.1 (FY 14/15) to promote the qualities of Calistoga that are attractive to residents and visitors.
