I am applying for the 'Citizen-at-large" position on the Calistoga Ad Hoc Library Renovation Review Committee.

Our Calistoga library is a wonderful community resource. A place where all ages gather to read, learn and discuss ideas. A place to gather for quiet reading or writing. A fun place for young people to learn the joys of reading with their peers and parents. Where else does this happen today?

We are very lucky to find ourselves with funds available from Napa County to make some necessary and significant changes to the building to make it work for us in the 21st century. It is important to move ahead deliberately to make these changes so that our library functions well. It can become a very vibrant element of our community life. A newly renovated library will bring a new enthusiasm for its resources and programs. We just need to get the public and the plans on the same page.

I am a life-long reader. My degree is in literature. I am a writer. I visit our library weekly and take home stacks of books each week. The library is my place. I would love to help this process of renovation move forward in a timely manner. I have a long history of renovation projects. My husband and I restored an 1878 Italianate Victorian and an 1894 Queen Anne Victorian in San Francisco. We acted as contractors on our present home, a 1935 Normandy cottage, renovating and modernizing it, yet preserving its character. I also worked with a committee to retrofit and renovate the Rectory of St. Luke's Church in San Francisco. I admire the variety of building ages and styles in Calistoga, and I appreciate thoughtful adaptive re-use of buildings when possible. I think I am good at finding the right balance. I would look forward to this challenge in updating our Library.

I have a long history volunteering in San Francisco with the Junior League, the Diocese of California, The San Francisco School Volunteers, Stanford Children's Hospital, Marin Country Day School and the Community Music Center. I have worked on boards for each group, often serving as President or Committee Chair. I am confident working in publicity, fundraising and community relations.

After moving to Calistoga I was a member of the Visioning Group, 1996-97, developing and leading architectural walks in the city, creating a slide show and planning a day-long community "idea day" to gather and prioritize the elements of the Vision for Calistoga's Future.

For many years I participated in the Napa County Master Gardener Program, 1999-2010, serving as President, Editor of our "Trees of Napa County" book, Publicity chair and various other positions, always trying to bring UCCE good gardening practices to the Calistoga public.

Now I am on the board of the Parkinson's Support Group of Sonoma County, specifically to develop a Parkinson's Dance Project in Santa Rosa for people with Parkinson's, their caregivers and friends.

I believe I have excellent leadership skills. I am a good listener and understand competing points of view. I can see the big picture and all the steps to reach success. I am diplomatic and well-spoken. I am comfortable in public forums and work well with the community to come to consensus. I am good at developing and staying on schedule to see a project to completion.
