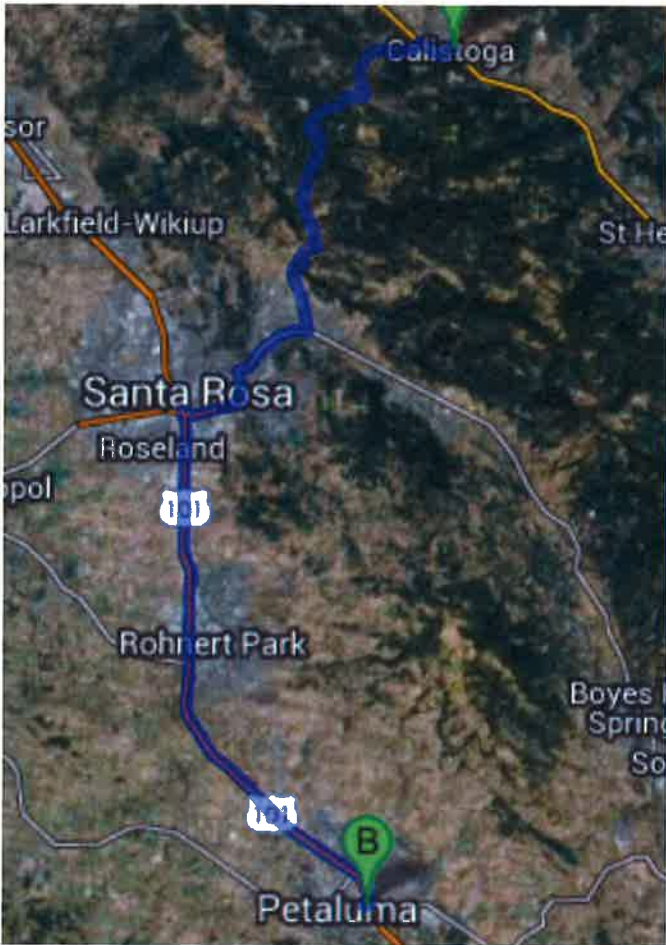

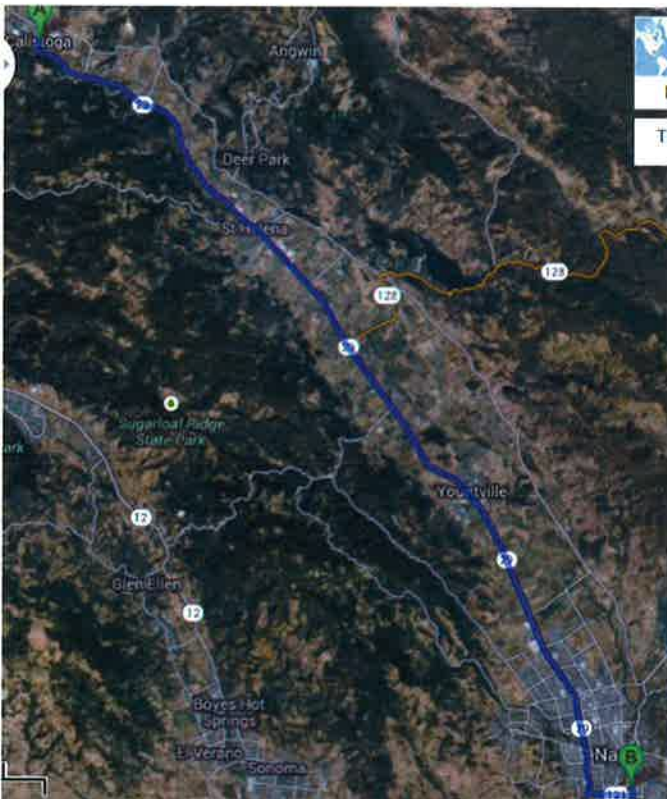


Petaluma Animal Shelter
