RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CALISTOGA,
COUNTY OF NAPA, STATE OF CALIFORNIA, AWARDING A
PROFESSIONAL SERVICES AGREEMENT TO ASSOCIATED ENGINEERING
CONSULTANTS INC. FOR PREPARATION OF PLANS AND BID
DOCUMENTS FOR THE 2015 MICRO SURFACING PAVEMENT
PRESERVATION PROJECT IN AN AMOUNT NOT TO EXCEED \$45,000

WHEREAS, on February 17, 2015 the City Council accepted the 2014 Pavement Condition Index (PCI) Report prepared by NCE Engineering through a grant from the Metropolitan Transportation Commission; and

WHEREAS, the 2014 PCI Report identifies that the City's overall pavement condition dropped 4 points since the 2012 from 56 to 52; and

WHEREAS, at the February 17, 2015 Council meeting the City Council directed staff to implement street improvements utilizing micro-surfacing and strategic reconstruction, and directed staff to identify the location where the micro-surfacing would be performed to provide the best return on investment and increase the overall PCI in the City; and

WHEREAS, it is necessary to engage the services of a consultant with experience in preparing plans and specifications for micro-surfacing street improvements; and

WHEREAS, staff has negotiated a scope of work with Associated Engineering Consultants Inc. who is qualified to provide the professional services needed for the preparation of bid documents and construction management services for micro-surfacing street improvements; and

WHEREAS, City staff recommends that a professional services agreement (PSA) be awarded to Associated Engineering Consultants Inc.in the amount not to exceed \$45,000 for the 2015 Micro Surfacing Pavement Preservation Project; and

WHEREAS, sufficient appropriations have been included in the proposed FY 15/16 Capital Improvement Budget - Pavement Maintenance (Fund 01-5402-4905-4915) for the PSA; and

WHEREAS, the 2015 Micro Surfacing Pavement Preservation Project is Categorically Exempt from CEQA pursuant to Section 15301 - Existing Facilities, under the Class 1 exemption.

NOW, THEREFORE BE IT RESOLVED that the City Council of the City of Calistoga hereby:

1. Approves the expenditure of \$45,000 for the preparation of plans and bid documents for the 2015 Micro Surfacing Pavement Preservation Project.
