**BACKGROUND / DISCUSSION**: City Council authorized an emergency river bank repair along Cyrus Creek for the Feige Tank water main on September 15, 2015 and awarded a contract to Maggiora & Ghilotti, Inc. A Notice to Proceed was issued on September 17, 2015.

This emergency work was necessary to prevent the river bank from eroding further which would have placed the water main in danger of collapse. If the water main failed it

could have potentially drained all of the City's stored domestic drinking water (from both
