AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF CALISTOGA, COUNTY OF NAPA, STATE OF CALIFORNIA, AMENDING CALISTOGA MUNICIPAL CODE TITLE 2, CHAPTER 2.04, SECTION 2.04.020, PERTAINING TO MEETINGS
THE CALISTOGA CITY COUNCIL DOES HEREBY ORDAIN AS FOLLOWS:
Section 2.04.010 of Chapter 2.04 of Title 2 of the Calistoga Municipal Code is amended to read as follows:
The regular meetings of the council shall be held on the first and third Tuesdays of each month at 6:00 p.m., or at such other times as such regular meetings may be adjourned to. If any regular meeting falls on a holiday, such regular meeting shall be held on the next business day which is not a legal holiday. Regular meetings shall be held at the Calistoga Community Center.
Effective Date. This Ordinance shall take effect thirty (30) days after its passage and before the expiration of fifteen (15) days after its passage, shall be published in accordance with law, in a newspaper of general circulation published and circulated in the City of Calistoga.

### ORDINANCE NO. - 466

AN ORDINANCE OF THE CITY OF CALISTOGA, COUNTY OF NAPA, STATE OF CALIFORNIA, AMENDING TITLE 2, CHAPTER 2.04, SECTION 2.04.010 OF THE CALISTOGA MUNICIPAL CODE PERTAINING TO MEETINGS

The City Council of the City of Calistoga does ordain as follows:

Section 2.04.010 of Chapter 2.04 of Title 2 of the Calistoga Municipal Code is amended to read as follows:

The regular meetings of the council shall be held on the first and third Tuesdays of each month at 7:00 p.m., or at such other times as such regular meetings may be adjourned to. If any regular meeting falls on a holiday, such regular meeting shall be held on the next business day which is not a legal holiday. Regular meetings shall be held at the Calistoga Community Center.

This ordinance shall take effect thirty (30) days after its passage, and before the expiration of fifteen (15) days after its passage, shall be published in accordance with law, in a newspaper of general circulation published and circulated in the City of Calistoga.
