 - The Railroad tracks on Washington Street: Almost ready for a bid to be submitted for the project.
 - Monhoff Building: The old roof was removed and the new roof has been installed. The plans are 100% complete and ready to issue permits for construction. There will be a meeting with the insurance adjusters next week. The plans will include a bathroom with some type of lift device for ADA compliance upstairs. The janitor's closet will be converted into a bathroom to include 3 bathrooms.
 - Kimball Reservoir is still full.
 - Wastewater treatment plant: 60,000,000-gallon pond is working well.
 The Public Works Department has submitted comments to the Water Board.
