ORDINANCE NO. 723

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF CALISTOGA, COUNTY OF NAPA, STATE OF CALIFORNIA, AMENDING CALISTOGA MUNICIPAL CODE TITLE 2, CHAPTER 2.04, SECTION 2.04.020, PLACE OF MEETINGS

THE CALISTOGA CITY COUNCIL DOES HEREBY ORDAIN AS FOLLOWS:

Section 2.04.010 of Chapter 2.04 of Title 2 of the Calistoga Municipal Code is amended to read as follows:

The regular meetings of the council shall be held on the first and third Tuesdays of each month at 6:00 p.m., or at such other times as such regular meetings may be adjourned to. If any regular meeting falls on a holiday, such regular meeting shall be held on the next business day which is not a legal holiday. Regular meetings shall be held at the Calistoga Community Center.

- A. Dates and locations of regular meetings of the council shall be established by resolution.
- B. The City may, from time to time, on an as needed basis, and at its sole discretion, hold duly noticed workshops, study sessions or other similar meetings, at dates, times and places, in accordance with the Brown Act and the wishes of the city council.
- C. Regular meetings can be adjourned to another date and time.

<u>Effective Date</u>. This Ordinance shall take effect thirty (30) days after its passage and before the expiration of fifteen (15) days after its passage, shall be published in accordance with law, in a newspaper of general circulation published and circulated in the City of Calistoga.

THIS ORDINANCE was introduced with the first reading waived at the City of Calistoga City Council meeting of the 18th day of October, 2016, and was passed and adopted at a regular meeting of the Calistoga City Council on the 1st day of November, 2016 by the following vote:
