ISSUE: Implementation of Urban Design Plan

RECOMMENDATION: Receive report from staff and provide direction as necessary

<u>BACKGROUND</u>: On January 19, 2010, the City Council adopted the Urban Design Plan. The UDP is intended to insure that the character of Calistoga is retained and enhanced through the maintenance and improvement of private and public properties and the refinement of land use policies and regulations. Many provisions of the UDP have subsequently been incorporated into the Calistoga General Plan and Municipal Code to better articulate the expectations of the community for future development and by doing so would assist property owners to understand the goals and desired elements of land development.

On April 20, 2010, the Council adopted the UDP Implementation Program, which includes public-initiated improvement projects. The action steps are divided into three priority groups.

<u>DISCUSSION</u>: Attachment 1 summarizes the status of each of the Plan's projects.

The General Plan and Zoning Code have been amended to integrate adopted UDP ideas and suggestions and/or map changes. Other efforts undertaken since the Plan's adoption include evaluating the State Highway 29/Silverado Trail and State Highway 128/Petrified Forest Road Intersections for possible improvements. Additionally, an

intern has inventoried existing wayfinding signage and made preliminary recommendations on designs and locations for new signage.

Staff efforts in the immediate future will continue to be focused on implementing the transportation improvements included in the UDP.

Many of the remaining projects call for the preparation of various studies that would require the hiring of outside consultants. The Council may wish to identify studies to be included in next fiscal year's budget, as funding allows.
