GENERAL LOCATION		GENERAL DESCRIPTION OF WORK:			
City of Calistoga, California, along Berry Street over the Napa River.		Installation of a pedestrian bridge to maintain pedestrian access over the river during the replacement of the existing roadway bridge at the site. The pedestrian bridge will be removed at the completion of the new bridge.			
REASONS THAT REQUESTED APPROVAL IS CONSIDERED TO BE COST-EFFECTIVE OR IN THE PUBLIC'S BEST INTEREST (STATE):					
The existing bridge currently serves as the primary access to the Calistoga Elementary School, which serves a large disadvantaged community in the City. The environmental document for the Berry Street Bridge Replacement, requires a pedestrian bridge be install during construction to maintain pedestrian access across the river to the local school. Installation of the pedestrian bridge is the critical path activity, it needs to be installed prior to demolition of the existing bridge. The lead time for the pedestrian bridge is 20 weeks for delivery to the site. To maintain the project schedule, the City will purchase the pedestrian bridge and supply it to the selected contractor as owner-supplied equipment. Cost Effectiveness Analysis: Through a competitive bid process, the City received 3 bids from different suppliers, the low bid was \$93,732.00 + Sales Tax of 8.0% = \$101,230.56 total purchase price. The equivalent rental cost for a temporary bridge was \$48,202.00, based on quotes received from suppliers. The federal funding participation for the project is based on the equivalent rental cost, the additional cost to purchase the bridge will be paid by the City. The City has other projects planned requiring a similar pedestrian bridge, so purchasing the bridge is preferred to minimize total costs for the City.

Purchase of the pedestrian bridge as owner-supplied equipment, provides the overall highest cost-effectiveness.
