**RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CALISTOGA, COUNTY OF NAPA,
STATE OF CALIFORNIA, ADOPTING THE APPROPRIATION LIMIT FOR
FISCAL YEAR 08-09 AND UPDATE FISCAL YEAR 07-08**

1 **WHEREAS**, the people of California on November 6, 1979, added Article XIII-B to the
2 State Constitution placing various limitations on the appropriations of the State and local
3 governments; and

4 **WHEREAS**, the State Legislature adopted Chapters 1205 and 1342 of the 1980 Statutes
5 which implemented Article XIII-B; and

6 **WHEREAS**, the people of California on June 5, 1990 amended Article XIII-B effective
7 July 1, 1990; and

8 **WHEREAS**, the provisions of the amendments have been interpreted by a coalition of
9 statewide organizations, and the organizations have issued through the League of California
10 Cities revised guidelines to recalculated the appropriations limit; and

11 **WHEREAS**, the Government Code provides the process in which to calculate the
12 appropriations limit and requires cities to adopt a resolution setting the annual appropriation
13 limit; and

14 **WHEREAS**, it is appropriate to review prior year appropriation limits and update the
15 calculations based on the final appropriations for the fiscal year; and

16 **WHEREAS**, the City of Calistoga has complied with the provisions of Article XIII-B in
17 determining the appropriations limit for Fiscal Year 08-09; and

18 **NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Calistoga that:

19 1. The annual adjustment factors used to calculate the FY 07-08 appropriations limit
20 shall be the change in Per Capital Personal Income (4.42%) and January 2007
21 County population (1.23%).

22 2. The FY 07-08 appropriation limit shall be \$9,700,491.

23 3. The FY 07-08 final appropriations subject to the appropriation limit is \$5,511,366.

24 **NOW, THEREFORE, BE IT FUTHER RESOLVED** by the City Council of the City of
25 Calistoga that:

26 1. The annual adjustment factors used to calculate the FY 08-09 appropriations limit
27 shall be the change in Non-residential assessed valuation (15.34%) and January
28 2008 County population (1.09%).

29 2. The FY 08-09 appropriation limit shall be \$11,310,501.

30 3. The FY 08-09 Adopted Budget appropriations subject to the appropriation limit is
31 \$5,786,734.
