As a small farmer, grape grower and wine maker living in Calistoga for almost 20 years, I bring a unique perspective on small farming in the Napa Valley. On my Garnett Creek Farm in Calistoga, I raise chickens, olives, bees and grapes. I make small lots of extra virgin olive oil, organic honey and single vineyard wines from the Napa Valley. I grew up in San Francisco and have lived in Calistoga since 2000. My family grew grapes in the Alexander Valley for many decades starting in the late 1960's -- exposing me to many agricultural and grape growing issues. I was active in 4-H and currently support youth ag activities through my Board membership on The Sebright Club of America.

As a consumer and frequent diner in local restaurants, I am a strong supporter of the farm-to-table movement, organic/bio-dynamic and sustainable farming. I also have investment experience in a number of local restaurants and am familiar with sourcing and other demand side issues relating to local sourcing.

In my earlier professional career, I ran a branding and marketing firm that included several agricultural clients, helping them with political and policy issues.
