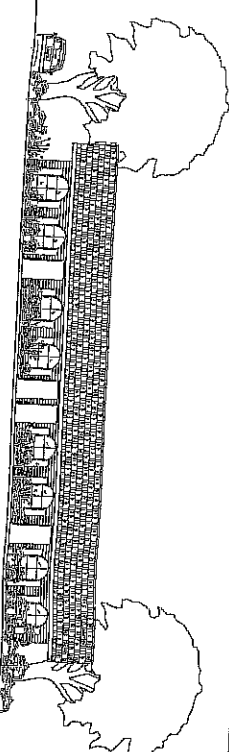

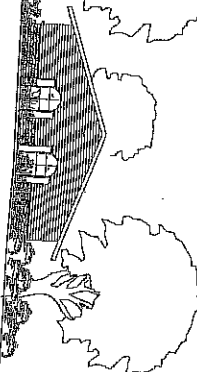
EAST ELEVATION (ANNEX)



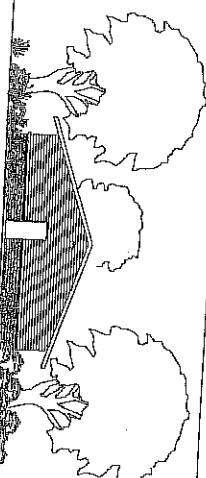
SOUTH ELEVATION (BOTH BLDG.)



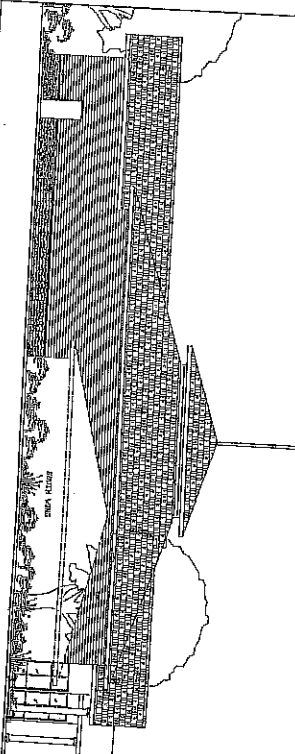
NORTH ELEVATION (ANNEX BLDG.)



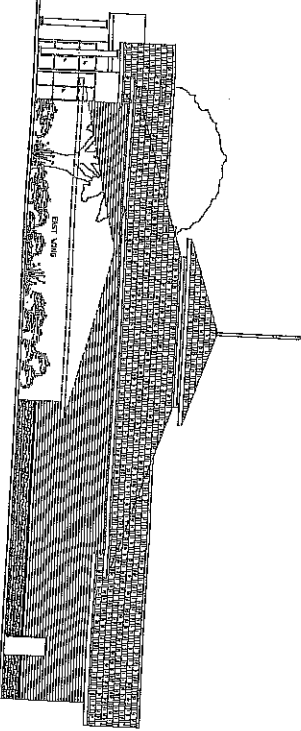
EAST ELEVATION (EAST WING)
