WHEREAS, the Planning Commission reviewed and considered this application at its regular meeting on December 6, 2006 and February 15, 2007, and prior to taking action on the application, the Commission received written and oral reports by the Staff, and received public testimony. After considering the project, the Commission adopted findings and approved the Project subject to conditions of Approval; and

WHEREAS, on February 23, 2007, the applicant appealed the Planning Commission's action to the City Council; and

WHEREAS, the City Council reviewed the appeal during a public hearing at it's regularly scheduled meeting on April 17, 2007 and adopted Resolutions 2007-30 through 33 adopting a Mitigated Negative Declaration and approving the project (Variances, Conditional Use Permits and Design Review);

WHEREAS, since the time of project approval the owner has made substantial progress in the preparation of all on and off site engineered improvement plans and architectural plans; and

WHEREAS, on February 15, 2008 Kelland Ingram, on behalf of Highlands Christian Fellowship requested more time to bring forward the building permit application and to provide the fees necessary to commence construction; and

WHEREAS, A Mitigated Negative Declaration for this project was previously adopted pursuant to Article 6 of the CEQA Guidelines, therefore, no additional environmental review need be prepared pursuant to Section 15162 of the State CEQA Guidelines.

NOW. THEREFORE, BE IT RESOLVED by the City of Calistoga Planning Commission that based on the previous Findings of the City Council, that the Planning Commission approves a one-year time extension for the Highlands Christian Fellowship Project, subject to the following conditions of approval:

- 1. This approval is for a one-year extension of time for the Highlands Christian Fellowship Project (i.e. Variances, Conditional Use Permit and Design Review) which authorized the construction of the Highlands Christian Fellowship and use of the Highlands Christian Fellowship building for the operation of a church, kindergarten and preschool all on the property located at 970 Petrified Forest Road within the "RR", Rural Residential zoning district. Any modification shall be subject to review and approval by the Director of Planning and Building and the Director of Public Works.
- 2. The Project shall comply with all required conditions approved by City Council Resolutions 2007-030 through 33.
- The Project shall expire on April 17, 2009. 3.
