<u>ISSUE</u>: Consideration of text amendments to the Calistoga Municipal Code, amending Title 2 (Council, Administration and Personnel) by adding a new section, Section 2.10.080 Director of Parks and Recreation

**RECOMMENDATION:** Introduce Ordinance and Waive First Reading.

**BACKGROUND/DISCUSSION:** The Calistoga Municipal Code Chapter 2.10 Other Officers defines certain positions and duties of officers within the City. Currently, Other Officers includes the following –

2.10.020 City Attorney
 2.10.030 Chief of Police

• 2.10.040 Director of Public Works

2.10.050 Administrative Services Director

• 2.10.060 Director of Planning & Building

• 2,10.070 City Clerk

Presently, the municipal code does not include the position of "Director of Parks & Recreation." Following Council deliberations and budget approval over the past several months, staff is presenting an ordinance amendment to create the position of "Director of Parks & Recreation" by municipal ordinance amendment. ### ORDINANCE NO.

# AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF CALISTOGA, COUNTY OF NAPA, STATE OF CALIFORNIA, ADDING CALISTOGA MUNICIPAL CODE SECTION 2.10.080 CREATING THE POSITION OF DIRECTOR OF PARKS & RECREATION

The City Council of the City of Calistoga does hereby ordain as follows:

# **SECTION ONE:**

**WHEREAS,** the City desires to improve and enhance the quality of life for Calistoga residents by providing quality, abundant and excellent recreation and parks programs for residents; and

WHEREAS, the City Council desires to achieve enhanced planning, organizational and administrative activities related to parks and recreation programs; and

WHEREAS, the Calistoga Municipal Code Section 2.10.080 establishes the position of Director of Parks & Recreation, who is appointed by and reports to the City Manager; and

WHEREAS, this action has been determined to not be subject to the California Environmental Quality Act (CEQA) under Sections 15061(b)(3), 15301, 15303, 15305 and 15332 of the CEQA Guidelines; and

WHEREAS, the City Council held a public hearing on July 17, 2018 to consider and deliberate this municipal code amendment and the staff recommendation.

#### **SECTION TWO:**

Title 2 (Council, Administration and Personnel) Section 2.10 (Other Officers) of the Calistoga Municipal Code is hereby revised to add Section 2.10.080, which reads as follows:

- A. Office. There is established the position of Director of Parks & Recreation, who shall be appointed by and report to the City Manager.
- B. Additional Duties. The Director of Parks & Recreation shall plan, organize and direct the programs and activities of the City's parks and recreation programs pursuant to the overall policies of the City Council and administer related programs, support and activities.

# **SECTION THREE.**

<u>Severability</u>. If any section, subsection, sentence, clause, phrase or word of this Ordinance is for any reason held to be invalid by a court of competent jurisdiction, such decision shall not affect the validity of the remaining portions of this Ordinance. The City Council of the City of Calistoga hereby declares it would have passed and adopted this Ordinance and each and all provisions hereof irrespective of the fact that any one or more of said provisions be declared invalid.

#### SECTION FOUR.

<u>Effective Date</u>. This Ordinance shall be effective thirty (30) days from and after the date of its passage.
