G. NEW BUSINESS

1. CDR 2007-07. Conceptual Design Review of the proposed demolition of an existing auto repair, storage, rental and towing business, and a mobile home for employee housing for the development of a Rite Aid Pharmacy, which will consist of approximately 11,180 sq.ft. of retail space, approximately 1,200 sq.ft. of a second floor stock room, 57 parking spaces, and a 2 lane pharmacy pick-up drive through facility. The subject property is located at 2449 Foothill Blvd (APN 011-360-003) within the Community Commercial-Design (CC-DD) District Overlay Zoning District.

<u>Recommended Action</u>: Review the proposed conceptual design plan, receive comments from the applicant and their representatives and the public, and provide preliminary comments to the applicant and staff as well as other issues of commission concern.

2. CDR 2007-06. Conceptual Design Review of the proposed redevelopment of existing warehouses into a mixed use development project consisting of 21 residential units and 1,194 sq.ft. of commercial space. Residential units will consist of 4 one-bedroom apartments over commercial use, 12 duet for-sale units, and 5 single family units with an optional granny flat. The proposal is to also recycle salvaged material from existing structures and integrate into the project. The subject property is located at 1506 Grant Street (APN 011-101-001) within the Community Commercial-Design (CC-DD) District Overlay Zoning District.

Recommended Action: Review the proposed conceptual design plan, receive comments from the applicant and their representatives and the public, and provide preliminary comments to the applicant and staff as well as other issues of commission concern.

H. PUBLIC HEARINGS

1. ZO 2007-06 and CMC 2007-04. Consideration of an Ordinance, initiated by the City of Calistoga, amending 17 (Zoning) and Title 5 (Business Taxes, Licenses and Regulations) of the Calistoga Municipal Code, specifically by adding sections 17.14.020(b), 17.22.060(b), 17.23.020(a), 17.26.020 and adding Chapter 5.14 to the Calistoga Municipal Code to regulate Hot Air Balloon Operations. This proposed action is exempt from the California Environmental Quality Act (CEQA) under Section 15061(b)(3) of the CEQA Guidelines.

Recommended Actions:

- a. Direct Staff to file a Notice of Exemption for the Project pursuant to Section 15061(b)(3) of the CEQA Guidelines upon City Council adoption of the Ordinance.
- b. Adopt Resolution PC 2007-40 recommending to the City Council adoption of an Ordinance amending Title 17 (Zoning) and Title 5 (Business Taxes, Licenses and Regulations) of the Calistoga Municipal Code, specifically by amending Sections 17.14.020(b),

17.22.060(b), 17.23.020(a), 17.26.020, 17.30.020 and adding Chapter 5.14 to the Calistoga Municipal Code to regulate Hot Air Balloon Operations (Refer to Attachment No. 1).

2. ZO 2007-05. Consideration of an Ordinance, initiated by the City of Calistoga, amending the Calistoga Municipal Code (Title 17 Zoning) to add Sexually Oriented Retail Businesses as a conditionally permitted use within the "DC" Downtown Commercial and "CC" Community Commercial Zoning Districts, and adding appropriate definitions and specific regulations to the Zoning Ordinance. This proposed action is exempt from the California Environmental Quality Act (CEQA) under Section 15061(b)(3) of the CEQA Guidelines. (This item was continued from the Planning Commission regular meeting of September 26, 2007.)

<u>Recommended Action</u>: Continue Zoning Ordinance Amendment (ZO 2007-05) to the next regular Planning Commission meeting of November 14, 2007.

NOTICE: If you challenge a City's zoning, planning, or other decision in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence delivered to the City at, or prior to, the public hearing. Judicial review of any City administrative decision may occur only if a petition is filed with the court not later than the 90th day following the date upon which the decision becomes final. Judicial review of environmental court determinations may be subject to a shorter time period for litigation, in certain cases 30 days following the date of final decision.
