MINUTES

CALISTOGA CITY COUNCIL REGULAR MEETING

Tuesday, April 2, 2019 - 6:00 P.M.

A) CALL TO ORDER - ROLL CALL

Mayor Canning called the regular session to order at 6:02 p.m.

In attendance were the following: Councilmember Gary Kraus, Councilmember Irais Lopez-Ortega, Councilmember Donald Williams, Vice Mayor Michael Dunsford and Mayor Chris Canning.

Also, in attendance: Acting City Manager/Public Works Director Michael Kirn, Administrative Services Director Gloria Leon, Police Chief Mitch Celaya, and City Clerk Irene Camacho-Werby.

B) SALUTE TO THE FLAG

Mayor Canning led in the Salute to the Flag.

C) REPORT FROM CLOSED SESSION

Mayor Canning stated there was nothing to report from **Item C1** of the March 27, 2019, Special Closed Session.

D) ORAL COMMUNICATION ON CONSENT ITEMS OR NON-AGENDA ITEMS

Mayor Canning opened Oral Communication.

Sheila Allen, Calistoga resident, raised concerns about speeding issues near her home on Foothill Boulevard and requested action be taken to remedy speeding violations.

Mayor Canning informed Ms. Allen of the City's current procedure for processing traffic concern requests.

Police Chief Celaya acknowledged the area is problematic and staff is working to increase police presence and exploring solutions.

Councilmember Williams thanked Ms. Allen for her comments.

Kevin Eisenberg, Calistoga resident, requested two items be added to a future City Council agenda:

- Connection from Logvy Park to S. Oak Street, as a priority project, as referenced in the Calistoga Active Transportation Plan proposed bikeways for improved transportation safety.
- 2. Provisions of entry level housing accommodations for local school teachers, City personnel, public safety employees and downtown staff.

Gopal Shanker, Napa resident, requested the item of a standardized electric vehicle permitting system be added to a future City Council agenda.

Following no further comments, Mayor Canning closed Oral Communication.

F) COUNCIL REQUESTS AND IDEAS FOR DISCUSSION

Councilmember Lopez-Ortega reported the Council is aware of the concerns at the Upper Valley Disposal site and everyone, including Calistoga residents can attempt to reduce waste through various efforts, including opportunities for reuse.

Councilmember Lopez-Ortega recommended holding community forums or neighborhood meetings instead of using social media to discuss upcoming agenda items.

Mayor Canning inquired when road repairs would be remedied on the State Highway portion of Lincoln Avenue in front of Ace Hardware, due to the road collapse damage a few months ago.

Acting City Manager/Public Works Director Kirn reported staff continues to communicate with CalTrans about the scheduled repairs and anticipates work beginning when the weather allows.

Mayor Canning reported the Lincoln Avenue Bridge is open and safe for passage. The ribbon cutting event will take place on Thursday, April 18th at 10 a.m.

Mayor Canning, as the City's representative on the Upper Valley Management Authority, which oversees Clover Flat Landfill and the City's franchise agreement with Upper Valley Disposal, reported an emergency meeting was held on April 1, 2019, at 1:30 p.m. The purpose of the emergency meeting was to address violations at the landfill which included some material seepage due to overflow that affected the creek. As a result, the landfill is under order to immediately make significant modifications to their operation. Another emergency meeting of the Authority is scheduled to take place on Friday, April 5, 2019, at 1:30 p.m. At this time the landfill is not accepting any public self-drop-off but will continue collections as per the franchise agreement.

G) CITY MANAGER'S REPORT

Acting City Manager/Public Works Director Kirn reported on the following items:

Installation has been completed for the way-finding signs. A total of three signs have been posted within City limits, including downtown.

Kimball Reservoir is completely full, all four flash boards are installed and contains 320-acre feet in storage. The State has increased the water allocation through the State Water Project and reported the City has over 1600-acre feet of their allocated amount.

Thanked the Calistoga Fire Department for their response to a fallen tree branch cutting across high voltage power lines at T-Vine Winery, located at 810 Foothill Blvd, Calistoga. The incident caused a small fire and Fire Department staff acted to provide safety precautions and contain the fire.

Councilmember Williams requested a report update on the discussion of the future removal of the Feige Dam.

Acting City Manager/Public Works Director Kirn reported staff is aware of the discussions for the Feige Reservoir. This item is not being actively pursued due to the costs as opposed to its benefits.

H) PROCLAMATIONS/PRESENTATIONS/AWARDS

1. Proclamation Recognizing April as Arts in April Month.

Mayor Canning read the proclamation recognizing April as Arts in April Month and presented it to Arts Council Napa Valley Programs Manager Bethany Crown.

Ms. Crown also introduced Arts Council Napa Valley Board Member Bill Gantt and Celebrate! Napa Valley's Programs Director Kelly Coudert.

Ms. Crown thanked the Council and announced several celebration events happening in April. More information can be found on www.artsinapril.com

Mayor Canning opened the public comment period.

No comments were forthcoming, therefor, Mayor Canning closed the public comment period.

3. Resolution authorizing a consultant services agreement with Coastland Engineers for an amount not to exceed \$96,069 for professional services related to preparation of plans and specifications for construction of a traffic signal and pedestrian safety improvements at Petrified Forest Road and Foothill Boulevard and approving a budget adjustment in the amount of \$104,143.

This item was pulled from the Consent Calendar for discussion.

Councilmember Lopez-Ortega recused herself from the discussion of the item, due to the proximity within 500 feet of her residence.

Acting City Manager/Public Works Director Kirn reported on the item.

Council and staff discussion ensued.

Mayor Canning opened the public comment period.

Tom Meyer, Calistoga resident, inquired about future funding needs to fulfill and complete the project.

Mr. Meyer also recommended the installation of a different method of improved pedestrian safety, such as an intersection flashing light and expanding turning lanes.

Mary Hastings, Calistoga resident spoke in support of the project and voiced concerns for the residents of Rancho de Calistoga, and the difficulty they appear to face when exiting and entering their property.

Vince Pasquariello, Calistoga resident and President of the Rancho de Calistoga Homeowners Association spoke in support of the project.

Dennis McNay, Calistoga resident and representing The Bear Flag Inn, inquired how funds will be allocated for the project.

Mr. McNay also voiced concerns regarding an increase in speeding issues in the area and suggested installing wider traffic lanes.

Acting City Manager/Public Works Director Kirn responded to questions regarding the funding of traffic impact fees and clarified that the budget adjustment is to move funds from a holding account to an account used for traffic impact fee project expenses.

Mayor Canning responded to inquiries about the installation of a traffic circle and the prior study completed by CalTrans and Napa Valley Transportation Authority. At the time the study was completed the City of Calistoga opted out of the project based on community input.

Mayor Canning also reported that several traffic studies have been done for this intersection

Charlotte Williams, Calistoga resident, reported witnessing several traffic violations at the intersection and suggested the City install two fixed flashing lights. Ms. Williams also inquired about the possible installation of traffic cameras.

Christine Stoner, Calistoga resident, reported her largest concern is highway safety and has witnessed several traffic violations and accidents. Ms. Stoner requested an increase in police presence and recommended the City review traffic impact along Foothill Boulevard, not only its intersection at Petrified Forest Road.

Following no further comments, **Mayor Canning** closed the public comment period.

Police Chief Celaya responded to inquiries and concerns raised by public comments. **Police Chief Celaya** also stated that the proposed project will alleviate traffic congestion, and staff will continue to be cognizant of potential future traffic measures that may be needed, as the project will not resolve all traffic concerns.

Mayor Canning reopened public comment.

Sheila Allen, Calistoga resident, inquired about "Radar Enforced" signs around the City and who is responsible for enforcement.

Mayor Canning responded that the signs are being enforced and staff will be working with the California Highway Patrol and the Napa County Sheriff's Department regarding radar enforcement.

Following no further comments, **Mayor Canning** closed the public comment period.

Council and staff discussion ensued.

Councilmember Lopez-Ortega rejoined the meeting at 7:35 pm.

4. Presentation from Clean Coalition regarding Calistoga Community Microgrid Concept and consider adopting a resolution approving a professional services agreement to perform a microgrid assessment.

Acting City Manager/Public Works Director Kirn reported on the item.

Mayor Canning welcomed back Dr. Frank Wasko, Managing Director with Clean Coalition and introduced Malini Kannan, Programs Engineer.

Dr. Wasko and Ms. Kannan presented the item.

Council and staff discussion ensued.

Mayor Canning opened the public comment period.

Debra Testa, Calistoga resident, commented and inquired on what the community stands to lose if the project moves forward and the value gained for the dollars spend on the project.

Mary Hastings, Calistoga resident, spoke in support of the project, agreed with previous speaker, Ms. Testa, and reported on the public meeting held by Pacific Gas and Electric (PG&E) on November 7, 2018, at the Calistoga High School.

Ms. Malini addressed questions regarding the history and length of time the Clean Coalition has been an active business.

Lorne Glaim, Calistoga resident, commented on green initiatives and inquired about the implementation process of a microgrid or microgrids, and ownership of the transmission lines.

Ms. Milani addressed questions regarding the processes for implementation of microgrids and transmission line ownership.

Mayor Canning provided information regarding the ownership of transmission lines and that the State of California is currently in discussions with PG&E.

Councilmember Kraus recommended searching nickel air batteries on YouTube for those interested in obtaining additional information about the product.

Charlotte Williams, Calistoga resident, reported on the public meeting held by Pacific Gas and Electric (PG&E) on November 7, 2018, at the Calistoga High School. Ms. Williams also inquired about the potential of incidents due to strong winds and the potential of transmission lines going down with a microgrid.

Ms. Milani addressed the question raised regarding threat of weather and loss of power from transmission lines.

Bill Geris, Calistoga resident, raised concerns regarding the use of PG&E's existing transmission lines and the potential loss of power due to wildfires and earthquakes.

Ms. Milani responded to the concerns raised regarding the use of PG&E's existing transmission lines.

Dennis McNay, Calistoga resident, spoke in support of the need to focus on emergency and critical needs of the City.

Following no further comments, **Mayor Canning** closed the public comment period.

Council and staff discussion ensued.

Vice Mayor Dunsford requested to delay taking further action on the item and discuss as a future agenda item or during budget discussions.

Councilmember Lopez-Ortega recommended moving forward with Phase 1 (Feasibility Assessment) only, to obtain information for future consideration before moving forward with the other phases of the project.

By consensus, the Council was in support of the recommendation.

It was MOVED by Mayor Canning to Adopt Resolution No. 2019-023 approving a professional services agreement with Clean Coalition to perform Phase 1 of a Calistoga community microgrid assessment, not to exceed \$26,000 and SECONDED by Councilmember Kraus.
