WHEREAS, on February 23, 2013, the City of Calistoga (City) entered into a Development Agreement (Agreement) with Resort at Indian Springs, LLC (Developer), (Ordinance No. 688); and

WHEREAS, the Agreement provided the Developer with certain assurances that they could proceed with a hotel expansion and restaurant development project; and

WHEREAS, the initial term of the Agreement was for a period of five years and the City Manager has extended the term twice by one year, to February 15, 2020; and

13 14 15 **WHEREAS**, as required by Government Code Section 65865.1 and by the Agreement, the City shall annually determine whether the Developer has, in good faith, substantially complied with the terms of the Agreement up to and including the date of the review; and

16 17 18 WHEREAS, at its meeting of February 5, 2019, the City Council considered the Annual Compliance Evaluation Form completed by the Developer that provides evidence of its good faith compliance with its obligations under the Agreement, and the facts as described in the staff report that the Developer has completed all of the improvements required of the project and paid all required fees; and

WHEREAS, the annual review of the Agreement is not subject to the California Environmental Quality Act (CEQA) under CEQA Guidelines Section 15061(b)(3) because it can be seen with certainty that there is no possibility it could have a significant effect on the environment.
