NOW, THEREFORE BE IT RESOLVED that the City Council of the City of Calistoga hereby authorizes the receipt an excess of \$4,100 in monetary and in-kind product donations from the aforementioned businesses and individuals.

NOW, THEREFORE BE IT FURTHER RESOLVED that the City Council of the City of Calistoga hereby approves a budget adjustment in the amount of \$800 to account numbers 87-3291-0007, 01-3299 and 87-4700-4799 for the acceptance of the monetary funds and a budget adjustment for the expenses incurred for the Calistoga Holiday Dinner in the amount of \$800 to account 01-4152-4401.
