5. Consideration of a resolution continuing a Proclamation of a Local Emergency related to COVID19 (Novel Coronavirus "COVID-19") until further notice

Recommended Action: Adopt resolution

City Manager Michael Kirn presented the staff report and cited specific action taken by each department (Attachment 1 - PowerPoint).

Mayor Canning praised the actions, resources and services provided by the County, City staff, non-profit organizations, and local businesses. Mayor Canning requested staff pay mind to Oat Hill Mine Trail signage to ensure safety for outdoor recreation. Mayor Canning asked the public to maintain civility and respect for one another.

Mayor Canning opened the public comment period.

City Clerk Kendall Rose Granucci read into the record public comments received via email from Jenni Norris (Attachment 2) and Lana Richardson (Attachment 3).

Mayor Canning acknowledged the public comments and closed the public comment period.

Councilmember Williams asked the Mayor to report back to Council any action or discussion of the County administrators with regard to face coverings.

It was MOVED by Councilmember Williams and SECONDED by Vice Mayor Dunsford to adopt Resolution No. 2020-025 declaring a continued State of the Existence of a Local Emergency in response to the threat to public health posed by COVID-19 and adopting rules and regulations thereto.

6. Consideration of a resolution approving an emergency funding request from Up Valley Family Center and approving a budget adjustment in the amount of \$200,000

Recommended Action: Adopt resolution

City Manager Michael Kirn presented the staff report.

Mayor Canning confirmed with City Manager Kirn that the Up Valley Family Center had exhausted all other opportunities for funding and was requesting relief from the City as a last resort option.

Councilmember Williams noted his conversation with Up Valley Family Center staff regarding the vetting of recipients and means for distribution of resources and he expressed support in recognition of the immediate response to a critical need.

Councilmembers Kraus and Lopez-Ortega and Vice Mayor Dunsford agreed with previous comments and voiced support.

Mayor Canning agreed with comments made and gave support to the previous actions of the Up Valley Family Center, acknowledging the fiscal responsibility demonstrated over the years. Mayor Canning asked that Up Valley Family Center exhaust all conversations with real estate owners before disbursing funds for rental assistance.

Councilmember Williams asked for clarification if the funds are specifically for Calistoga residents, to which City Manager Kirn confirmed, the funds would be disbursed to those within the Calistoga city limits.

Mayor Canning opened the public comment period.

Having no members of the public come forward, **Mayor Canning closed the public comment period.**

It was MOVED by Councilmember Williams and SECONDED by Councilmember Lopez-Ortega to adopt Resolution No. 2020-026 authorizing an emergency relief funding request from Up Valley Family Center in the amount of \$200,000 for local community support and approving a budget adjustment.

7. Consideration of dates for City Council Study Sessions for goal setting and Fiscal Year 2020-21 Budget review

Councilmembers expressed unanimous support for the proposed dates for budget review.

Councilmember Kraus expressed concern regarding public participation at 3:00 p.m. versus 6:00 p.m. but acknowledged that due to shelter at home order most of the public is home and available and Councilmember Williams acknowledged some members of the public who may not be able to attend at the regular 6:00 p.m. time may be available to participate at the earlier afternoon hour.

Councilmembers expressed unanimous support for the City Council Regular Meeting time to be changed to 3:00 p.m. through end of May.

Councilmember Williams asked for overview of the budget process, to which City Manager Kirn replied with explanation that the budget is drafted based on previous year budgets then provided to Council for review.
