G. PUBLIC HEARINGS

1. Lincoln Avenue Apartments Entitlement Renewal Design Review DR 2020-8 and Use Permit UP 2020-10 (DR 2018-7 and UP 2018-9)

Consideration of design review and use permit renewal applications for a 78-unit apartment building and off-site improvements on a 2.89 acre parcel on Lincoln Avenue (APN 011-050-044), originally approved by the Planning Commission on December 12, 2018. An affordable housing density bonus and associated concessions/incentives were also previously approved by the Planning Commission on December 12, 2018. This proposed action is exempt from the California Environmental Quality Act (CEQA) under Section 15332 of the CEQA Guidelines.

Recommended Action: Hold a public hearing and approve design review and use permit renewal resolution with conditions.

2. Mount View Hotel and Veraison Restaurant Parking Lot to Patio Conversion Design Review DR 2020-9 and Use Permit UP 2020-9

Consideration of design review and use permit applications to permit the permanent conversion of an existing surface parking lot at 1457 Lincoln Avenue (APNs 011-205-014 & -018) to hotel & restaurant patio space. This proposed action is exempt from the California Environmental Quality Act (CEQA) under Section 15303 of the CEQA Guidelines.


Recommended Action: Hold a public hearing and approve design review and use permit resolution with conditions.

DECISION: For applications that require review by the City Council, the Commission's action is a recommendation to the Council. In cases where no other action is required, the action of the Commission is final unless appealed.

APPEALS: Anyone who does not agree with the Planning Commission's decision or the conditions that have been imposed by the Commission in approving an agenda item may appeal the Commission's action to the City Council. Appeals must be filed within 10 calendar days from the date of the Commission's action. Appeals may be limited to those issues raised at the public meeting. For additional information concerning the requirements for filing an appeal, please contact the Planning & Building Department, 1232 Washington Street, Calistoga or call 707.942.2830.

NOTICE: If you challenge the City's decision in court, you may be limited to raising only those issues you or someone else raised at the public hearing, or in written correspondence delivered to the City Council at, or prior to, the public hearing. Judicial review of any City administrative decision may be heard only if a petition is filed with the court not later than the 90th day following the date upon which the decision becomes final. Judicial review of environmental determinations may be subject to a shorter time period for litigation, in certain cases 30 days following the date of final decision.

SPECIAL ASSISTANCE: Each City entity offers public programs, services, and meetings in a manner that is reasonably accessible to everyone, including individuals with disabilities. Each City entity complies with all applicable requirements of the Americans with Disabilities Act and California law, and does not discriminate against any person with a disability.
