1. **Continued Item: Dr. Wilkinson's Mural – Sign Permit SP 2020-4:** Consideration of a sign permit design review for a proposed mural on the Fair Way façade of the Dr. Wilkinson's resort at 1507 Lincoln Avenue (APN 011-092-038). This proposed action is exempt from the California Environmental Quality Act (CEQA) under Section 15301 of the CEQA Guidelines.
2. **Indian Springs Food & Beverage Expansion – Design Review DR 2020-10 and Use Permit UP 2020-12:** Consideration of design review and use permit applications to permit the addition of a new food & beverage establishment with outdoor dining near Lincoln Avenue on the lawn of the Resort at Indian Springs at 1712 Lincoln Avenue (APN 011-340-027). **DECISION:** For applications that require review by the City Council, the Commission's action is a recommendation to the Council. In cases where no other action is required, the action of the Commission is final unless appealed.

**APPEALS:** Anyone who does not agree with the Planning Commission's decision or the conditions that have been imposed by the Commission in approving an agenda item may appeal the Commission's action to the City Council. Appeals must be filed within 10 calendar days from the date of the Commission's action. Appeals may be limited to those issues raised at the public meeting. **NOTICE:** If you challenge the City's decision in court, you may be limited to raising only those issues you or someone else raised at the public hearing, or in written correspondence delivered to the City Council at, or prior to, the public hearing. Judicial review of any City administrative decision may be heard only if a petition is filed with the court not later than the 90th day following the date upon which the decision becomes final. Judicial review of environmental determinations may be subject to a shorter time period for litigation, in certain cases 30 days following the date of final decision.

**SPECIAL ASSISTANCE:** Each City entity offers public programs, services, and meetings in a manner that is reasonably accessible to everyone, including individuals with disabilities.
