I feel that the least the Planning Commission could do is approve something that actually depicts the history of Calistoga. We have had too many urbanites move into this town and "improve" it to their liking, which does not improve it for those who have lived here for generations. The last thing we need a mural that has no meaning for Calistoga and those who have lived here for generations. This place is already too much of a tourist town and there are so many activities that the tourists flock here for. I would not mind seeing a big TOURISTS GO HOME! sign myself. I was just thinking the other day how much I used to enjoy the tractor parade, but once all of the thousands of tourists started coming the locals were crowded out of the front row seats in town. Heck, you almost can't get a reservation for dinner at one of the restaurants on a weekend in a regular year, let alone find parking if you have to go into town (2020 does not count for anything normal). It would be nice to respect the history of this town. My great-grandfather came here from Italy. Got a plot of land and then sent for my great-grandmother to come here. Carlo Marchiori is a superb artist and his murals contain details that reveal themselves with time and viewing. I think this new mural, although absolutely and completely different, may also reveal itself slowly to people as they really look at it.
