Councilmember Gift asked if the City Council could support a different location for the Grad Night Celebration.

Councilmember Kraus stated he supports Mr. Kaiser's comments. Police Chief Celaya stated that often there is a lack of clarity between the State and County guidelines which are supposed to mirror each other but can easily be interrupted differently which has been a challenge.

Vice Mayor Lopez-Ortega extended her gratitude to Adventist Health, Napa County Health Department and all running the COVID-19 vaccination clinic in St. Helena. Vice Mayor Lopez-Ortega would like to explore providing the vaccine to elderly residents.

Mayor Canning thanked Adventist Health and St. Helena Hospital for quickly setting up a vaccination center at the Upper Valley Campus of Napa Valley College located in St. Helena. We are continuing to push to have a vaccination center in Calistoga but there are many challenges including the lack of supply available.
