The Covid 19 pandemic has changed the way guests of the hotel and customers of the restaurants will relax, dine and congregate. The new guidelines space hotel seating (lounge chairs, sofas etc.) and restaurant seating (table & chairs) **outdoors** and over a **large area** to provide social distancing in an effort to reduce or eliminate the possibility of transmission. As you are aware, we were granted a temporary permit to do this and have remodeled our parking lot so to accommodate the Covid-19 guidelines. Currently, neither the hotel or restaurant could operate without this additional space.

As we all know, Calistoga businesses began to recover until we were faced with another disaster....the fire. What business we had has now disappeared. Another setback, more financial consequences. We will endure and now we cannot fathom not having the space for our guests and customers. The additional space is essential for our recover and is also the highest and best use of the space. We now ask for our temporary expansion to become permanent.

Please find enclosed a slightly revised set of drawings that we submitted in May that include the new glass wall required by the Napa County Environmental Health Department and the emergency exit and lighting required by the building department. Also enclosed is our application, fee and a photo board of the improvements.

We have found replacement parking for the 13 stalls that were eliminated. Bill Shaw has agreed to rent us 13 parking stalls at the rear of his  $1^{st}$  Street parking lot. Attached please find from our architect a drawing depicting the stalls and their location.

Below is more detail on our "Weekend Dinner and Movie" proposal.

- 1. It is for hotel guests only (with one exception a fundraiser for Calistoga Cares November 2020).
- 2. It runs Friday, Saturday and Sunday nights.
- 3. We have always had dining in our backyard. The reasoning behind the theater seating was for our hotel guests who wanted to see a movie after dining could simply walk to outdoor theater next door and the guests that did not, could continue to dine and relax. Our program is dinner and a complimentary movie. The movie is designed to enhance the experience of the dinner.
- 4. We do not want to run a movie theater.....no dinner no movie.
- 5. There is no dining at the theater, only on the patio.
- 6. Our theater is just outside 4 of our guest rooms. We have set the sound volume so not to disturb our guests or neighbors. Our immediate neighbor is a retail establishment closing at 7pm. The movies run 1 ½ hours at dust (spring and fall ending at 9pm and summer ending at 10pm)
