## **RESOLUTION NO. 2021-049**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CALISTOGA, COUNTY OF NAPA, STATE OF CALIFORNIA, DESIGNATING THE INTERSECTION OF WASHINGTON AND LAKE STREETS AS A THREE-WAY STOP AND DIRECTING THE PUBLIC WORKS DIRECTOR TO INSTALL AND MAINTAIN THE REQUIRED ADDITIONAL STOP SIGNS AND MARKINGS AT THAT INTERSECTION

**WHEREAS**, the intersection of Washington and Lake Streets is a three-way intersection currently with a stop sign at the Lake Street entrance; and

WHEREAS, the intersection of Washington and Lake Streets is along key routes for cyclists and pedestrians including the primary route from the Junior/Senior High School to the facilities at Logvy Park; and

WHEREAS, the Calistoga Active Transportation Advisory Committee has indicated a strong preference for a three-way stop at the intersection of Washington and Lake Street; and

**WHEREAS**, the City Council has determined that traffic safety factors merit the erection of additional stop signs at the intersection; and

WHEREAS, the California Manual on Uniform Traffic Control Devices (CA-MUTCD) allows the engineer to warrant an all-way stop control at this intersection subject to meeting a certain criteria; and

**WHEREAS**, the City Engineer has determined that this intersection meets the criteria set forth in CA-MUTCD to warrant an all-way stop control; and

## NOW, THEREFORE, BE IT RESOLVED THAT THE CITY COUNCIL OF THE CITY OF CALISTOGA DOES RESOLVE, DECLARE, DETERMINE AND ORDER AS FOLLOWS:

- 1. That the intersection of Washington and Lake Street shall require a stop at all three intersection entrances, per the authority granted under CMC Section 10.24.010.
- 2. That the Director of Public Work is directed to install and maintain two additional stop signs at the intersection, and to make other improvements as necessary.
- 3. That a budget amendment of \$4,600 to pay for the project is authorized to Account #01-5402-4915 (Pavement Maintenance Fund).
