### REBATE TERMS AND CONDITIONS

- 1) Applicant must own the property or obtain authorization for participation in the Program from the property owner (see below).
- 2) The property on which the replacement toilets will be installed must be served by the City of Calistoga water system and the water account must be in good standing with no delinquent charges (except for mobile homes that do not pay water utilities).
- 3) Applicant must attach receipts with purchase price circled and schedule a water survey offered by the Water Conservation Program.
- 4) Applicant must retain the replaced toilet(s) until the GPF (1.6 or higher) have been verified by the Water Conservation Team at the inspection. Applicants who will have the replaced toilet disposed of by the installer must schedule pre- and post-installation inspections or have the installer verify and document the GPF of new and old toilets. Applicants must schedule an inspection with the Water Conservation Team at least one week before the installation date, and another once the new toilet has been installed.
- 5) New toilet(s) must have a U.S EPA WaterSense label (1.28 gallons per flush or less model).
- 6) Only toilets purchased or installed after January 1, 2022 are eligible for a rebate.
- 7) Rebate application must be complete and is subject to verification, including all necessary documentation such as proof of purchase.
- 8) The maximum rebate amount is \$125 per qualifying toilet and does not include sales tax, shipping or installation. Toilets with 1.28 gpf may qualify for a \$100 rebate, while toilets with 1.1 gpf or less may qualify for a \$125 rebate. Rebate applies to purchase of qualifying toilet tank and toilet bowl only. Applicant/contract labor will not be rebated. The maximum rebate per property is \$250 and is subject to funding availability.
- 9) Application must be submitted within 90 days of HE Toilet purchase and will be processed on a first-come, first-served basis.
- 10) Rebate checks will be mailed to the applicant 6-8 weeks after the City receives all completed documentation and verifies the gallons per flush of old and new toilets.

The undersigned further agrees to defend, indemnify and hold harmless the City, its directors, officers, agents, and employees, from and against any and all loss, damage, expense, claims suits and liability, including attorney’s fees arising out of or in any way connected with the toilet(s) and its (their) installation. Applicant has read, understands and agrees to the terms and conditions listed on the WaterSense Toilet Rebate Program application. Applicant understands that installation of a qualifying high-efficiency toilet may not result in lower water bills. The City reserves the right to add or remove eligible high-efficiency toilets from the list or change the terms of the incentive offer at any time.
