REBATE TERMS AND CONDITIONS

1. Applicant must own the property or obtain authorization in the Program from the property owner.
2. The property on which the replacement clothes washer will be installed must be served by the City of Calistoga water system and the water account must be in good standing with no delinquent charges (except for mobile homes that do not pay water utilities).
3. Applicant must attach receipts with purchase price circled.
4. Applicant must schedule a site visit with the City Water Conservation Program to inspect the old washer before it is taken away, and to inspect the new washer before it is installed. Applicants must schedule an inspection with the Water Conservation Team at least one week before the installation date, and another once the new washer has been installed OR at the time of installation if both washers are on-site at the same time. The inspections serve to verify the water efficiency of the new washer and the type and manufacturing date of the old washer.
5. New washers must be front-loading and have an EPA EnergyStar Label, and the old washers to be replaced must be top-loading and must have been manufactured in 2014 or earlier.
6. Only washers purchased and installed after January 1, 2022 are eligible for a rebate.
7. Rebate application must be complete and is subject to verification, including all necessary documentation such as proof of purchase.
8. The maximum rebate amount is \$200 per qualifying clothes washer, and does not include sales tax, shipping or installation. The rebate only applies to the purchase of a qualifying clothes washer. Applicant or contract labor will not be rebated. The maximum rebate per property is \$200 and is subject to funding availability.
9. Application must be submitted within 90 days of the EnergyStar labeled clothes washer purchase and will be processed on a first-come, first-served basis.
10. Rebate checks will be mailed to the applicant 6-8 weeks after the City receives all completed documentation and verifies the Integrated Water Factor of the new and old clothes washers.

Acknowledgements

I am voluntarily participating in the High-Efficiency Clothes Washer rebate program and will comply with the above terms and conditions. I will independently select materials, supplies and labor for the purpose of performing the installation. I agree that all work performed will comply with applicable state and local laws, ordinances, and regulations.

The undersigned expressly agrees that

- The City of Calistoga may inspect all properties participating in the EnergyStar High-Efficiency Clothes Washer Rebate Program
- The City does not guarantee the performance of any clothes washer
- The City does not warrant any clothes washer or installation to be free of defects, the quality of workmanship or the suitability of the premises or clothes washer for installation.
- The undersigned further agrees to defend, indemnify, and hold harmless the City, its directors, officers, agents and employees from and against any and all loss, damage, expense, claims, suits and liability, including attorney’s fees arising out of or in any way connected with the clothes washer and its installation. The applicant has read, understands, and agrees to the terms and conditions listed on the High-Efficiency Clothes Washer Rebate Program application. The applicant understands that the installation of a qualifying high-efficiency clothes washer may not result in lower water bills. The City reserves the right to add or remove eligible high-efficiency clothes washer from the list or change the terms of the incentive offer at any time.
