7.2 Consider adopting a Resolution approving the 2022 Parade/Event Schedule and Authorizing the Public Works Department to Apply for Encroachment Permits from Caltrans.

7.3 Consider adopting a Resolution authorizing and entering into A Joint Use Agreement ("Agreement") with the Calistoga Joint Unified School District("District") to provide for the use of City-owned or managed public facilities by the District and for the use of District-owned or managed public facilities by the City; and a Schedule and Reimbursement Agreement for use of the Calistoga Community Pool by the Calistoga Joint Unified School District.

7.4 Consider adopting a Resolution authorizing the purchase of a 2022 Ford Interceptor 6-cylinder Eco Boost SUV and outfit the patrol vehicle with equipment and markings not to exceed \$62,912 and accept the insurance reimbursement of the purchase and outfitting costs minus the \$10,000 deductible.

8. PUBLIC HEARING

8.1 Consideration the appeal of a use permit and design review renewal application for a three-guest unit expansion project and associated on-site improvements at the Aurora Park Cottages located at 1807 Foothill Boulevard (APN 011-290-046). The application was originally approved by Planning Commission on February 26, 2020, with an approval of renewal on February 9, 2022.

Recommended Action: Consider adopting a Resolution denying Appeal AP 2022-2 thereby upholding Planning Commission approval of application UP 2022-1 and DR 2022-1, finding the project categorically exempt from CEQA, and approving Use Permit Application UP 2022-1 and Design Review Application DR 2022-1.

Mayor Canning stated that Drought is here, it is not going away, please entertain best practices. Mayor Canning commented that yes, we have staff issues, and we are not alone and that we are making every effort to fill open positions and that we must reset our expectations as a City Council on what is deliverable.
