Rebate – Ultra High Efficiency Toilet for Commercial & Multi-Family Property

REBATE OFFER

For commercial properties or multi-family residential properties with 3 or more units, property owners or managers can receive \$50 per toilet, up to 10 toilets. Existing toilets must be 1.6 gallons per flush or more, and the replacement toilets must be 1.1 gallons per flush (gpf) or less.

REBATE TERMS

- 1) Applicant must own the property or obtain authorization for participation in the Program from the property owner (see below).
- 2) The property on which the replacement toilets will be installed must be served by the City of Calistoga water system, and the toilets being replaced must be serviced by City of Calistoga Water. Toilets serviced by spring water or well water do not qualify for the rebate.
- 3) The water account must be in good standing with no delinquent charges.
- 4) The property must be commercial or multi-family residential (3 or more units).
- 5) Property owners or managers can apply for this rebate no more than once every five years.
- 6) Only toilets purchased or installed after November 15, 2022 are eligible for a rebate.
- 7) Rebate application must be complete and is subject to verification, including all necessary documentation such as proof of purchase.
- 8) The maximum rebate amount is \$50 per qualifying toilet, up to 10 toilets per property, and does not include sales tax, shipping or installation. The rebate applies to purchase of qualifying toilet tank and toilet bowl only. The cost of labor will not be rebated. The maximum rebate per property is \$500.
- 9) Rebates are subject to funding availability. Applications will be processed in the order they are received. A qualifying application does not guarantee a rebate.

TOILET EFFICIENCY VERIFICATION

- 10) New toilet(s) must have a U.S EPA WaterSense label and be 1.1 gallons per flush or less.
- 11) Applicant must have a City of Calistoga employee verify the gallons per flush (gpf) of the existing toilets before their removal and the gpf of the new toilets after they have been installed.
- 12) Applicant must attach receipts with purchase price circled.
- 13) Applicant must retain the replaced toilet(s) until the GPF (1.6 or higher) have been verified by the Water Conservation Team at the inspection.

APPLICATION SUBMISSION

- 14) Application must be submitted within 90 days of HE Toilet purchase and will be processed on a first-come, first-served basis.

PAYMENT

- 15) Rebate checks will be mailed to the applicant 6-8 weeks after the City receives all completed documentation and verifies the gpf of the old and new toilets.
