### 8. GENERAL GOVERNMENT

8.1. Lincoln Avenue (Hwy 29) Parklets need to be removed or permitted to stay by Caltrans by 12/2023. This item was presented by Public Works Director Derek Rayner

Public comment was made by Erick Reichert, Clive Richardson, Mr. Dierkhising and Mr. Ali in support of keeping the parklets. Dan Herndon spoke against keeping the parklets.

The Council discussed and Staff was directed to pursue the Caltrans permits and a formal agreement with the businesses simultaneously.

Mayor Williams made a motion, seconded by Councilmember Eisenberg to keep the parklets for another year with the City taking on the permitting expenses not to exceed \$18,000 and without making this an annual commitment, only if the businesses formalize an agreement to take over the responsibility for maintaining, cleaning and keeping the parklets compliant with Caltrans rules and regulations.
