## 7. PUBLIC HEARING

7.1. Consider an Ordinance of the City of Calistoga Amending Title 17, Zoning. Chapter 17.19 R-3 Multifamily/Office District and Chapter 17.22 CC Community Commercial District such that Reuse Sites in the 2023-2031 Housing Element (Assessor Parcel numbers 011-062-008, 011-072-020 and 011-050-024) that will accommodate lower income households shall not be subject to discretionary review if 20 percent of the proposed units are affordable to lower-income households.

Mayor Williams and Councilmember Gift were recused during this item due to a property proximity conflict.

Interim Planning and Building Director Meyer and Attorney Murphy presented the item.

7.2. Consider an Ordinance of the City of Calistoga Amending Municipal Code Chapter 5.12 Mobile Food Vendors, Section 5.12.010 E. 2. regarding where mobile vending vehicles may conduct vending.

8.2. Decision on Scheduling a Public Hearing to Consider a Councilmember Appeal of a Planning Commission Decision Approving an Automobile Sales and Repair Use Permit Within Existing Facilities at 1856 Lincoln Ave (APN 011-050-010).

This item was presented by Councilmember Gift who spoke with concern that although the Planning Commission did a good job, the public may not have had enough of a chance to weigh in and provide public comment.

The Council discussed and directed staff to bring this item back to the Council for a public hearing as soon as possible.

**Councilmember Cooper** - Would like to bring up to the rest of the Council that the price for grocery bags is going up to .25, almost triple what it is now and would like the Council to reconsider this part of the ordinance, The Council was in support.

**Councilmember Eisenberg and Gift** - Attended the Climate Action Committee - Calistoga's Foodware Ordinance is the first like it and was very well written, in fact the committee will be modeling their ordinance after ours.

Vice-Mayor Lopez Ortega - Attended Flood Control and Blue Zones Meetings, there will be an event tomorrow at Calm-mart at 11:30 am to celebrate them. She also said the Water

Conference for Latino Leaders is coming to San Jose and hopes Councilmembers can make it.

**Mayor Williams** - Thanked the Councilmembers for attending all these meetings and representing our City. He attended a NV Tourism Meeting and an NVTA Meeting which will be bringing to Council a few revisions.
