Councilmember Gift reported that she will be attending the Fairgrounds cleanup day on Oct 19th and invited any high school students needing to earn community service credit to attend, she has secured waiver forms.

Councilmember Eisenberg attended a Green Committee meeting and they are working very hard on the RCAAP document. Also, the NVTA has submitted a claim to PG&E for 3 million dollars for the cost of the overruns and setbacks of the Vine Trail.

Vice Mayor Lopez-Ortega attended the high school presentation and was impressed by the students' good ideas. She and Councilmember Gift will be attending the League of California Cities annual conference and representing Calistoga.

Mayor Williams reported he was pleased to attend the high school government class presentations. He and Councilmember Eisenberg attended the NVTA meeting and it is public now that we will be paying more money than we anticipated, there was a discussion of options for recovery. Williams also attended a NV Tourism Corporation meeting. 10 years ago the City approved the process by which the board operates and the fund collection, it will soon come back before the Council for approval. He asked staff to look into Mr. Solari's comment about the invasive French Broom plant on city property, the rest of the Council concurred.
