After Council discussion, it was agreed that there would not be any changes to the current eligibility requirements of the Community Enrichment Grants.

Vice Mayor Lopez-Ortega is happy to report that she and staff attended a Blue Zones event where the City received an award for being a healthy community. She also attended the Harvest Table event, it was a successful event and she ran into people who came all the way from Mexico City specifically to attend. Lopez-Ortega stated she would soon be asking for Council support in placing a request from Hearts and Hands on the agenda regarding the lease of a building at the Fairgrounds. Mayor Williams and Councilmembers Cooper and Gift were not in support of adding this item to the agenda yet as there are still requests coming in and the condition of the building is a concern.

Councilmember Eisenberg attended a Climate Action Committee meeting, they are still working on the regional plan which he expects will come before the Council soon. Eisenberg continues to ride on the Vine Trial, it has been busy and it is becoming a great addition to our community.
