SUBJECT: CONDITIONAL USE PERMIT (U 2000-06(A)) TO AMEND USE

PERMIT U 2000-06 TO ALLOW AMPLIFIED MUSIC AND LIVE

ENTERTAINMENT AT LA PRIMA PIZZA RESTAURANT

REQUEST

U 2000-06(A): Consideration of a Conditional Use Permit application requesting an amendment to Use Permit U 2000-06 to allow amplified music and live entertainment indoors or outdoors any time during business hours at property located at 1923 Lake Street (APN 011-535-010) within the "CC-DD", Community Commercial-Design District Overlay Zoning District. This proposed action is exempt from the California Environmental Quality Act (CEQA) under Section 15301 of the CEQA Guidelines. (This item was continued from the Planning Commission Meeting of August 12, 2009.)

BACKGROUND

On August 12, 2009, the Planning Commission considered a Conditional Use Permit application submitted by the owners of La Prima Pizza restaurant requesting an amendment to Use Permit U 2000-06 to allow amplified music and live entertainment indoors or outdoors any time during business hours at property located at 1923 Lake Street. After receiving a report and presentation from staff and in consideration of oral and written testimony from members of the public, the Planning Commission appointed a sub-committee to review the operating parameters recommended by staff and assist the applicant in working with nearby residents to identify acceptable terms under which live entertainment could be permitted at the restaurant. The Planning Commission then continued the item for further discussion at a regularly scheduled meeting in September, 2009.

UPDATE

Since August 12, 2009, the appointed subcommittee has reviewed the operating parameters for live entertainment that were recommended by staff and made several revisions (Attachment 1). The intent of the subcommittee's review and revision is to establish a "bottom line" that the subcommittee is willing to recommend for Commission approval. It is the hope of the subcommittee that with this understanding, neighbors and the business owners will be able to hold a productive discussion on the suggested bottom line parameters and work together to

tailor the suggested parameters to the satisfy the interests of both the residents and the business owner.

Planning staff met with the applicant to review the revisions forwarded by the subcommittee on September 8, 2009. The applicant indicated their willingness to accept the suggested revisions, but also expressed an interest in presenting their own modifications to the revised operating parameters for consideration by the neighborhood (Attachment 2).

The next steps in the review process are to conduct a test live entertainment event and hold a follow-up neighborhood meeting. A test live entertainment event will be held on Friday, September 25, 2009, between the hours of 6:00 p.m. and 9:00 p.m. The event will include indoor and outdoor events. Noise measurements will be taken at various locations during the event in an effort to assess noise levels/impacts to nearby residences.

Following this event, a neighborhood meeting will be held on Tuesday, September 29, 2009, at 6:00 p.m. in the Community Center to review observations made during the test live entertainment event and discuss potential operating parameters.

Notice of both events has been sent to property owners within 300 feet of the business and to parties who submitted correspondence in response to the Use Permit amendment request.

Staff with Applicant consent is requesting that the Planning Commission continue its review of this item to the regularly scheduled meeting of October 14, 2009, to allow time for additional staff evaluation and for further discussion between the business owner and the neighbors.

RECOMMENDATION

Continue the Public Hearing to October 14, 2009.
