Dear Ms. Kenyon

As you know, La Prima Pizza in Calistoga has requested a modification to their use permit. This modification is in direct conflict with the City of Calistoga General Plan – specifically, the Noise Element and Calistoga's Entry Corridor/Gateway Areas; both local and state laws and ordinances as well as their Conditional Liquor License under the Alcoholic Beverage Control (ABC).

This business, La Prima Pizza, has a long and continuing history of violations with existing laws and codes including under-age drinking in and around the business, noise disturbance, traffic problems, parking in adjacent residential neighborhoods, property damage to neighboring residential structures, litter in the area, drug deals in the parking lot, amplified music without a use permit multiple times, and more - all documented in a long list of police reports which I have in my position. La Prima owners have refused to turn down music when contacted by police and stated that they do not intend to comply with their existing use permits or ABC liquor license to police and others – as recorded by numerous police records and in planning commission meetings.

We request a Cease and Desist on all Administrative Use Permits (AUP) at this facility due to their numerous and continued disregard (well over three times in the past several weeks alone) for their current use permit. We are also asking for a Cease and Desist for any consideration of any change in this use permit of any kind – amplified music, live music, outdoor or indoor music or loud voices, special events, or anything else that would require a permit. We ask that La Prima continue business without this modification on this malicious and nonsense addition to a residential neighborhood.

We are aware that city officials have met in secret with La Prima owners for the purpose of guiding them toward this modification. In addition to that announcements for meetings have failed to meet requirements of the Ralph M. Brown Open Meeting Act (commencing with Government Code Section 54950) which requires cities and counties to provide advance public notice of hearings and meetings of their councils, boards, and other bodies. Meetings and hearings must be open to the public.

We have reached out to La Prima and asked them to turn down the music on multiple occasions, all to no avail. We have then phoned the police and both Mr. Nunez and Mrs. Nunez, on separate occasions, refused to cooperate with police. My children have been prevented from going to sleep at night and have been frightened by the power of the music which shook the windows of our home and could be heard inside with the doors and windows closed. My children were crying and frightened during these times. There have been incidents when we have been awakened during the night by loud music, automobiles revving engines, loud groups of people outdoors at La Prima - and we cannot get any relief even though police are called out several times per incident. Our children are consequently experiencing mental and emotional stress due to the ongoing disturbance and noise. They are fearful and we are unable comfort them back to sleep for hours when they hear this music.

We have attended public meetings on this since July and voiced our concerns in person and in writing. We have made repeated requests for a professional sound study which have been ignored. We have been given no explanation describing the reasons that this project has not been subject to CEQA nor has there been a negative declaration report as we would expect – in particular, with respect to ambient noise, parking concerns, litter, traffic, City corridor & other aspects of the city's general plan, and all other potential impacts within the area affected by the requested modification to this use permit.

We are asking you, as the City Attorney, to evoke the law.

We are also requesting that you attend the next Planning Commission meeting of the City of Calistoga, scheduled for Monday, November 16, 2009 at 5:30pm.

Our family will have no recourse but to seek a detailed civil suit for damages and civil rights violations against the City of Calistoga, City Manager, Jim McCann and Charlene Gallina and perhaps others for non-enforcement of both City Code and violation of CEQA if our requests are not promptly met.

They have added a lot to the community both personally and professionally. They are always there in support of a cause or when help is needed. They are a friendly outgoing family who is only looking to add to the great community that they live in. I am proud to support their establishment.

Subject: La Prima cited for serving Alcohol to Minors

Dear friends and neighbors,

It has come to our attention that La Prima Pizza has two recent violations against their Liquor License, one for serving alcohol to minors. We would like the City to look into this before proceeding forward with the request to alter the La Prima Use Permit.

We mentioned this to Ken McNab this evening when he was apparently conducting an unannounced "sound test" in our neighborhood. He stated that since he and not seen these violations himself he was not interested in knowing about them. We informed him that this information is public record with the ABC (Alcohol Beverage Control) and asked him to verify this for himself as we felt it was important. He flatly refused to honor this request stating that he would absolutely not contact the ABC nor consider this with regard to the requested change in the La Prima Use Permit to allow amplified music. We find this particularly egregious and disturbing. La Prima holds a full liquor license and intends to have indoor and outdoor parties for large groups of minor children with live amplified music. In addition, while advertising as a venue for children, school parties and birthday parties La Prima, stated that they were considering extending their service of alcohol to 2:am.

When we were speaking with Mr. McNab, he said that this was a "nice quiet neighborhood" and that we have room for a lot more noise here.

Mr. McNab's tone and manner were confrontational even though he was in our neighborhood at our dinner hour and we were discussing a matter that directly impacts us in our home and our lives. We would like to go on the record with a complaint against Mr. McNab's conduct. When he was on the sidewalk in front of our home his manner was extremely upsetting and we were compelled to ask him to leave.

We cannot help but feel that our rights are being trampled on by a single special interest and that Mr. McNab and perhaps others are not working for the overall good of the citizens of this city. This has already become very stressful for us and disruptive for our family, and our entire way of life.

We ask you for expressed support on this matter. Please contact city officials.

Dear Mr. Mac Nab:

This is to memorialize our telephone conversation of yesterday afternoon, September 17, 2009. In that conversation I conveyed to you that I had had several phone calls from disturbed citizens of Calistoga. They were all very upset that the Planning Commission had met in secret with the owners of La Prima Pizza, without any notice or input from the citizens of Calistoga and allowed them to have a party on September 25, 2009, with outdoor amplified music.

Aside from the outrage of the citizenry, I expressed my concern that this meeting, whether face to face or by e-mail, as you stated it was, was likely in violation of the Brown Act. The public has a right to know when such meetings are held and has the right to express opinions concerning such actions.

I also expressed to you that noise was not the only issue with these so-called parties, which are, in reality, money-making events for La Prima Pizza. My clients are very concerned about the amount of police attention that this venue brings, especially when these outdoor music events are going on. They have reported property destruction, urinating in their yards, drunk driving in the neighborhood, and the general unruliness created by these events. Some of the residents have conveyed to me that they did not report the events to the police because they were afraid of retaliation from the owners of La Prima Pizza. Others reported the events but no reports were made because the citizens were not aware that it was necessary to expressly request that a report be made. I also received a copy of a letter to you from Kristin Casey, expressing her concerns about the obvious violation of the Calsitoga General Plan.

We are hoping that the commission will reconsider this event and find a more scientific way to measure the noise and general disruption that these events cause, and to pay more attention to the disruption that has already been reported and documented by the Calsitoga Police Department. It seems unreasonable and even cruel to the citizens of Calistoga to put them through another of these events to see if it really is noisy.

We are hoping to avoid litigation but these citizens feel that their rights to peaceful enjoyment of their homes is being violated and that the city General Plan and the nature of the community are also being violated.

Thank you for your attention to this matter.

Dear Ken McNab,

I am writing to express strongest opposition to the proposed "Live Entertainment Test" at La Prima Pizza.

La Prima currently does not have a permit for amplified music. At the last Planning Commission meeting where this was brought up residents were told there would be a public meeting on this with a special committee. This has not occurred. Residents also requested numerous times that a noise impact study be done prior to continuing the application for the requested change to the use permit. This has not been done.

According to the Calistoga General Plan, this is an area of town where the decibels already exceed the noise limit. We don't need a band to perform at La Prima Pizza in order to determine if the noise would be too loud for the residents and the church – all lying within very close proximity to La Prima. As you well know, the La Prima location has a long history of unwanted activity, especially related to live and amplified music, and police action.

In addition, it has become clear that private, closed door, conversations between the City and La Prima owners to make plans for this proposed "Live Music Test" have taken place. This is in clear violation of the Brown Act which guarantees the public's right to attend and participate in local government meetings and to prevent local government bodies from attempting to avoid public scrutiny by holding secret meetings such as the one you, the City, have had with La Prima owners.

We worked hard and saved our entire life to purchase our home in the quiet corner of Calistoga that we have called home for six years. We are raising our young children here. We do not intend to allow the selfish interests of one and the misguided abuse of power of the City of Calistoga to usurp our enjoyment of our home or to interfere with our daily life.

The Calistoga City's General plan specifically states: In Calistoga, noise is particularly important given the interest in retaining the small-town character of the community and because of the community's tradition of being a destination for rest and relaxation...Noise is ... objectionable when it interferes with people's daily life, such as in the evening when people are having conversation over dinner, or trying to sleep.

Amplified music at La Prima has already failed this test as police reports and the history of the location prove. Please also note that, in addition to the noise concern, a letter I already submitted to the Planning Commission with multiple signatures states that noise is not the only concern. Events with amplified music present a host of nuisance issues that cannot, in my view, be mitigated in this residential neighborhood. La Prima and the City have not made any attempt to acknowledge or address these factors.

We respectfully insist that this request for a change to the use permit be denied. We also request that a professional noise study from an unbiased professional company – such as was done by the pool project – paid for by La Prima Owners – not the City – be done PRIOR TO ANY AMPLIFIED MUSIC AT LA PRIMA.

Ken,

Thank you for the public notice about your proposed "live entertainment test" for La Prima.

I wonder if you have had the opportunity to read the General Plan's Noise Element, which lauds Calistoga on being a "relatively quiet" town and which distinctly mandates that Calistoga shall "preserve current low levels of noise to maintain the City's rural atmosphere" and that Calistoga will "protect residents from the undesirable effects of excessive noise."

In addition, the General Plan calls for "ensuring noise exposure compatibility between neighboring land uses." One pertinent Action Item at page N-20 directs the City to "Revise the Noise Ordinance so that it contains quantitative measures to maintain Calistoga's existing low level of noise, as well as measures to address localized, temporary noise sources...."

The La Prima business has for as many years as I can remember been barred from having amplified music [and the business was purchased by the current owners with that knowledge], because it is not located in the central business area of town and is adjacent to residential neighborhoods.

In addition, this area is arguably within one of Calistotga's Entry Corridor/Gateway areas and the intent of the General Plan in regard to our gateways is that our rural small-town character will be especially preserved, and that uses in the gateways will not compete with Calistoga's downtown commercial core. Frankly, if City staff are in favor of amplified music at this gateway and if our appointed and elected representatives fail to adhere to the original intent for business in a gateway area, then I fear that our other gateways into town could be at risk of future businesses wanting amplified music which would interfere with residents' peace and quiet in their homes.

It has historically been the intent of the citizens of Calistoga that this place of business be a restaurant, not a loud music venue. I'm not sure I understand why City staff would promote the proposal for amplified music here and disregard the lengthy history of this issue, and why the very real concerns from residents of Calistoga would not be given the weight they deserve. Those of us who live in Calistoga value the fact that we can come home from work at the end of a work week and relax in relative peace in our own homes -- amplified music at the gateways to town, near residential areas that haven't historically had this kind of noise, would go a long way toward destroying our time at home.

I don't know why an "event test" is being conducted, given the clear mandate and spirit of our General Plan.



Summary

I am strongly opposed to the request to modify the CUP at 1923 Lake Street to allow amplified music. As you know, the business exists in a commercial overlay to a residential area. The back deck where the pizza parlor proposes amplified music is approximately 100 yards from my property, facing directly into my own back patio. In the past when the pizza parlor has presented (unpermited) amplified music, it has literally shook my windows. The many negative and unacceptable impacts that this CUP modification presents include traffic, safety, quality of life, property value, noise, and privacy.

History

The structure at 1923 Lake Street was once owned by my grandparents, Alfredo and Argentina Falleri, who purchased it in 1924 along with 15 acres of land after immigrating from Italy. What is now the pizza parlor was their home. In 1935, they gave a piece of their land at Lake Street and Money Lane to their daughter Olivia and her new husband, Fred Heitz, and they built a home there, where I now live. After my grandmother Argentina passed away in the early 1970s, their house was sold. Over the years, single family homes surrounded the old house and the neighborhood remained appropriately quiet. The businesses that eventually came to occupy my grandparents' old house always respected the nature of the neighborhood. Occasionally live music would be presented but it was always unamplified acoustic music that would not impact the surrounding neighborhood. There has never been a precedent for the kind of amplified music that the pizza parlor is now requesting.

Current Situation

My house is located at 1901 Lake Street. The only thing that separates me from the pizza parlor are the old zinfandel vines that my grandparents planted, and which I continue to tend. The center of activity at my house has always been the back patio, which over the years has hosted innumberable get-togethers, parties, receptions, July 4 celebrations and so on. But beyond that, the patio is where I spend most afternoons, reading, puttering in the garden, checking on the vines, and enjoying the peace and quiet that is synonymous with living in Calistoga. Because of this, activity at the pizza parlor is a constant element of my life. I can see and hear people coming and going, kids yelling and running around their deck, customers chatting and laughing while they enjoy their food, and so on. I have

always respected owners of the pizza parlor, and have never complained about noise or tried to do anything that that would impact their ability to run a thriving business. In other words, following in the tradition that I learned in 72 years of living in Calistoga, I have tried to be neighborly.

Impacts

Noise. With this request for amplified music, I feel like the owners of the pizza parlor are not reciprocating. They are not being neighborly. It is astonishing to me that the idea of live amplified music in a quiet residential neighborhood would even be requested or considered. When they have tried to present live music in the past, it has made it impossible to be outside - it is simply too loud. And when I have gone inside, it has been hard to even hear my own television. There would simply be no way for me to live in my own home while the music was being presented.

Quality of Life. Live amplified music changes the atmosphere of any establishment where it is presented. This is why it's important to also ban live amplified music from being allowed inside the parlor. When amplified music is allowed, the atmosphere of the entire estbalishment changes from family-oriented to more of a drinking and "party" atmosphere. This would be inappropriate in a residential neighborhood.

Traffic safety. The poorly-conceived five-way intersection in front of the pizza parlor is a well-known safety hazard. Does the planning commission really want to accept liability for further increasing the hazard there by accepting a CUP modification that could well increase the probability of drunk drivers who will attempt to negotiate that dangerous intersection as they leave the pizza parlor?

Property value. Allowing a loud business in proximity to my home will decrease my property value. Further, my brother and I presently own three acres of open, in-fill residential land adjacent to the pizza palor property. At some point we will want to develop this land with much-needed Calistoga housing. But who will want these houses if they are next to an establishment that blares live music into their backyards?

Privacy. As it is, customers who eat on the back deck of the pizza parlor have an unobstructed view into my back yard, my windows and so on. Increasing the activity on the deck will further degrade my sense of privacy.

In conclusion, I strongly encourage you to deny the modification request.
