Thank you in advance for reading this letter to the City Council and public in attendance.



Dear Mr. Hawkins:

On November 18, 2009, I received your request for public records requesting copies of minutes and DVD copies of the Planning Commission meetings of August 12, 2009, October 14, 2009 and November 16, 2009.
